Hi Joe:

Can we get a third amendment to AB 648 and SB 439. It would be a notwithstanding clause related to ignoring the required statutory reserve. SA 1 and AA 2 relating to the Pension Protect Act would reduce estimated revenues in 2010-11, thereby reducing our estimated balance. With our January revenue estimates, we are already below \$65 million required by statute. Please draft this as a JFC amendment. We discussed having a substitute amendment drafted, but decided no. Let me know if you have any questions.

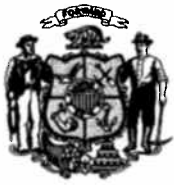
