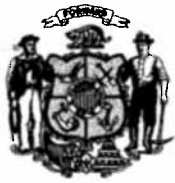

- 4 "SECTION 5m. 119.23 (10m) of the statutes is created to read:
- 5 119.23 (10m) Section 118.42 (2), (3) (b) (intro.) and 1. and (c), (4), and (5) applies
- 6 to private schools participating in the program under this section, insofar as
- 7 applicable. For the purpose of this section, the following terms used in s. 118.42 have
- 8 the meaning indicated:
- 9 (a) "Public school" means a private school participating in the program under
- 10 this section.
- 11 (b) "School board" means the governing body of a private school participating
- 12 in the program under this section.

1 (c) “School district superintendent” means administrator.”.
