Hi Pam,

Senator Lassa would like an amendment drafted to SB 450 to state that the reimbursement rate for the Badger Care Basic plan be at least that of the M.A. Rate. She would also like a provision to include that DHS report to JFC quarterly about the solvency of the Basic Plan and that if there becomes a point in the future where the BC Basic Plan becomes insolvent, DHS report to JFC immediately with their plan to fix or wind-down the program without state assistance. Senator Lassa is defining the "insolvent point" to be when the department does not have enough money to pay the claims.

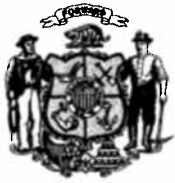

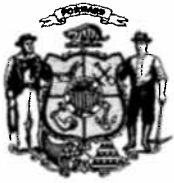
