

# PRELIMINARY DRAFT NOT READY FOR INTRODUCTION SENATE AMENDMENT, TO 2009 SENATE BILL 484

Nersons

At the locations indicated, amend the bill as follows:

1. Page 7, line is: after that line insert:

3 "(7m) AUDIT. The legislative audit bureau shall perform a performance evaluation audit of the plan under this section one year after the effective date of this subsection .... [LRB inserts date]. The bureau shall submit copies of the audit report to the chief clerk of each house of the legislature for distribution to the appropriate standing committees under s. 13.172 (3).".
