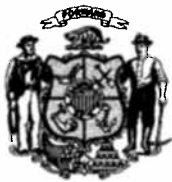
Sen. Vinehout would like to offer 3 amendments to SB 484:

1. Would establish a sunset of the Badger Basic program in 2 years after enactment.
2. Would require the Legislative Audit Bureau to complete a comprehensive program audit one year after enactment.
3. I will be getting language for an amendment regarding cascading eligibility... basically requiring DHS to review an applicant's eligibility for other options for coverage. I am supposed to have draft language tomorrow and I will get it to you as soon as possible.
