1 **AN ACT** *to renumber* subchapter III of chapter 440 [precedes 440.41], subchapter
2 IV of chapter 440 [precedes 440.51], subchapter V of chapter 440 [precedes
3 440.60], subchapter VI of chapter 440 [precedes 440.70], subchapter VII of
4 chapter 440 [precedes 440.88], subchapter VIII of chapter 440 [precedes
5 440.90], subchapter IX of chapter 440 [precedes 440.96], subchapter X of
6 chapter 440 [precedes 440.97], subchapter XI of chapter 440 [precedes 440.98],
7 subchapter XII of chapter 440 [precedes 440.9805] and subchapter XIII of
8 chapter 440 [precedes 440.99]; **to amend** 157.055 (2) (intro.), 441.15 (2m),
9 448.03 (2) (a) and 632.895 (12m) (b) 4.; and **to create** 440.03 (13) (b) 15m.,

11 632.895 (12m) (b) 3m. of the statutes; **relating to:** licensure and regulation of

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1.** 157.055 (2) (intro.) of the statutes, as affected by 2009 Wisconsin
4 Act 42, is amended to read:

5 157.055 **(2)** (intro.) Notwithstanding ss. 69.18 (4), 445.04 (2), 445.14, 979.01 (3),
6 (3m), and (4), 979.02, and 979.10, and subch. ~~VI~~ VII of ch. 440, during a period of a
7 state of emergency related to public health declared by the governor under s. 323.10,
8 a public health authority may do all of the following:

9 **SECTION 2.** 440.03 (13) (b) 15m. of the statutes is created to read:

10 440.03 **(13)** (b) 15m. Behavior analyst.

11 **SECTION 3.** 440.08 (2) (a) 20m. of the statutes is created to read:

12 440.08 **(2)** (a) 20m. Behavior analyst: December 15 of each even-numbered
13 year.

17 **SUBCHAPTER III**

18 **BEHAVIOR ANALYSTS**

19 **440.310 Definitions.** In this subchapter:

1 **(1)** “Behavior analyst” means a person who is certified by the Behavior Analyst
2 Certification Board, Inc., as a board–certified behavior analyst and has been granted
3 a license under this subchapter to engage in the practice of behavior analysis.

4 **(2)** “Practice of behavior analysis” means the design, implementation, and
5 evaluation of systematic instructional and environmental modifications to produce
6 socially significant improvements in human behavior, including the empirical
7 identification of functional relations between behavior and environmental factors,
8 known as functional assessment and analysis, including interventions based on
9 scientific research and the direct observation and measurement of behavior and
10 environment. “Practice of behavior analysis” does not include psychological testing,
11 neuropsychology, psychotherapy, cognitive therapy, sex therapy, marriage
12 counseling, psychoanalysis, hypnotherapy, and long–term counseling as treatment
13 modalities.

14 **440.311 Use of title; penalty. (1)** No person may use the title “behavior
15 analyst” or represent or imply that he or she is a behavior analyst unless the person
16 is licensed under this subchapter. This section may not be construed to restrict the
17 practice of behavior analysis by a licensed professional who is not a behavior analyst,
18 if the services performed are within the scope of the professional’s practice and are
19 performed commensurate with the professional’s training and experience, and the
20 professional does not represent that he or she is a behavior analyst.

21 **(2)** Any person who violates sub. (1) may be fined not more than \$250,
22 imprisoned not more than 3 months in the county jail, or both.

23 **440.312 Licensure. (1)** Except as provided in sub. (2), the department shall
24 grant a license as a behavior analyst to a person under this subchapter if all of the
25 following apply:

1 (a) The person submits an application to the department on a form provided
2 by the department.

3 (b) The person pays the initial credential fee determined by the department
4 under s. 440.03 (9) (a).

5 (c) The person submits evidence satisfactory to the department that the person
6 is a behavior analyst certified by the Behavior Analyst Certification Board, Inc., or
7 its successor organization.

8 (2) The department may not grant a license under this subchapter to any
9 person who has been convicted of an offense under s. 940.22, 940.225, 940.302 (2) (a)
10 1. b., 944.06, 944.15, 944.17, 944.30, 944.31, 944.32, 944.33, 944.34, 948.02, 948.025,
11 948.051, 948.06, 948.07, 948.075, 948.08, 948.09, 948.095, 948.10, 948.11, or 948.12.

12 **440.313 Renewal.** (1) The renewal date for licenses granted under this
13 subchapter is specified in s. 440.08 (2) (a). Renewal applications shall be submitted
14 to the department on a form provided by the department and shall include the
15 renewal fee determined by the department under s. 440.03 (9) (a).

16 (2) A behavior analyst shall, at the time that he or she applies for renewal of
17 a license under sub. (1), submit proof satisfactory to the department that he or she
18 is, at the time he or she applies for renewal, certified by the Behavior Analyst
19 Certification Board, Inc., or its successor organization.

20 **440.314 Rules.** (1) The department may promulgate rules necessary to
21 administer this subchapter, including rules of conduct by behavior analysts and by
22 holders of temporary permits under sub. (2). Except as provided in subs. (2), (3), and
23 (4), any rules regarding the practice of behavior analysis shall be consistent with
24 standards established by the Behavior Analyst Certification Board, Inc., or its
25 successor organization.

1 **(2)** (a) The department may promulgate rules authorizing the department to
2 issue a temporary permit to a person who is certified by the Behavior Analyst
3 Certification Board, Inc., or its successor organization authorizing the practice of
4 behavior analysis by the person under the supervision of a behavior analyst licensed
5 under s. 440.312 (1).

6 **(3)** The rules may not do any of the following:

7 (a) Require an applicant for a license under this subchapter to have education
8 in addition to the education required by the Behavior Analyst Certification Board,
9 Inc., or its successor organization.

10 (b) Require a behavior analyst to practice behavior analysis under the
11 supervision of, or in collaboration with, another health care provider.

12 (c) Require a behavior analyst to enter into an agreement, written or otherwise,
13 with another health care provider.

14 (d) Limit the location where a behavior analyst may practice behavior analysis.

15 **440.315 Informed consent.** A behavior analyst shall, at an initial
16 consultation with a client, provide a copy of the rules promulgated by the department
17 under this subchapter and shall disclose to the client orally and in writing all of the
18 following:

19 **(1)** A summary of the behavior analyst's experience and training.

20 **(2)** Any other information required by the department by rule.

21 **440.316 Disciplinary proceedings and actions.** **(1)** Subject to the rules
22 promulgated under s. 440.03 (1), the department may conduct investigations and
23 hearings to determine whether a violation of this subchapter or any rule
24 promulgated under this subchapter has occurred.

1 **(2)** Subject to the rules promulgated under s. 440.03 (1), the department may
2 reprimand a behavior analyst or deny, limit, suspend, or revoke a license granted
3 under this subchapter if the department finds that the applicant or the behavior
4 analyst has done any of the following:

5 (a) Intentionally made a material misstatement in an application for a license
6 or for renewal of a license.

7 (b) Subject to ss. 111.321, 111.322, and 111.34, practiced behavior analysis
8 while his or her ability to engage in the practice was impaired by alcohol or other
9 drugs.

10 (c) Advertised in a manner that is false or misleading.

11 (d) In the course of the practice of behavior analysis, made a substantial
12 misrepresentation that was relied upon by a client.

13 (e) In the course of the practice of behavior analysis, engaged in conduct that
14 evidences an inability to apply the principles or skills of behavior analysis.

15 (f) Obtained or attempted to obtain compensation through fraud or deceit.

16 (g) Allowed another person to use a license granted under this subchapter.

17 (h) Violated any law of this state or federal law that substantially relates to the
18 practice of behavior analysis, violated this subchapter, or violated any rule
19 promulgated under this subchapter.

20 (i) Engaged in unprofessional conduct.

21 **(3)** Subject to the rules promulgated under s. 440.03 (1), the department shall
22 revoke a license granted under this subchapter if the behavior analyst is convicted
23 of any of the offenses specified in 440.312 (2).

1 **440.317 Advisory committee.** The department may appoint an advisory
2 committee under s. 440.042 to advise the department on matters relating to the
3 regulation of behavior analysts.

4 **SECTION 5.** Subchapter III of chapter 440 [precedes 440.41] of the statutes is

1 **SECTION 16.** 441.15 (2m) of the statutes is amended to read:

2 441.15 **(2m)** Subsection (2) does not apply to a person granted a license to
3 practice midwifery under subch. ~~XII~~ XIII of ch. 440.

4 **SECTION 17.** 448.03 (2) (a) of the statutes is amended to read:

5 448.03 **(2)** (a) Any person lawfully practicing within the scope of a license,
6 permit, registration, certificate or certification granted to practice midwifery under
7 subch. ~~XII~~ XIII of ch. 440, to practice professional or practical nursing or
8 nurse–midwifery under ch. 441, to practice chiropractic under ch. 446, to practice
9 dentistry or dental hygiene under ch. 447, to practice optometry under ch. 449, to
10 practice acupuncture under ch. 451 or under any other statutory provision, or as
11 otherwise provided by statute.

12 **SECTION 18.** 632.895 (12m) (b) 3m. of the statutes is created to read:

13 632.895 **(12m)** (b) 3m. A behavior analyst who is licensed under s. 440.312.

14 **SECTION 19.** 632.895 (12m) (b) 4. of the statutes, as created by 2009 Wisconsin
15 Act 28, is amended to read:

16 632.895 **(12m)** (b) 4. A paraprofessional working under the supervision of a
17 provider listed under subds. 1. to ~~3.~~ 3m.

18 **SECTION 20. Nonstatutory provisions.**

19 (1) The department of regulation may promulgate rules under section 440.314
20 of the statutes, as created by this act, as emergency rules under section 227.24 of the
21 statutes. Notwithstanding section 227.24 (1) (c) and (2) of the statutes, emergency
22 rules promulgated under this subsection may remain in effect until the effective date
23 of permanent rules promulgated by the department under section 440.314 of the
24 statutes, as created by this act. Notwithstanding section 227.24 (1) (a) and (3) of the
25 statutes, the department is not required to provide evidence that promulgating a rule

1 under this subsection as an emergency rule is necessary for the preservation of the
2 public peace, health, safety, or welfare and is not required to provide a finding of
3 emergency for a rule promulgated under this subsection.

4 **SECTION 21. Initial applicability.**

5 (1) If a disability insurance policy or a governmental self-insured health plan
6 that is in effect on the effective date of this subsection contains a provision that is
7 inconsistent with this act, this act first applies to that policy or plan on the date on
8 which it is renewed.

9 **SECTION 22. Effective dates.** This act takes effect on the day after publication,
10 except as follows:

11 (1) The creation of subchapter III of ch. 440 of the statutes takes effect on the
12 30th day after publication.
