- 2 **1.** Page 3, line 9: before "does not" insert "is a charge internal to the commission and".
 - **2.** Page 3, line 10: delete "to the commission".
- 5 **3.** Page 3, line 11: after "par. (b)" insert "is a transfer of funds internal to the commission and".
 - 4. Page 3, line 18: delete "nursing home".
- 8 **5.** Page 3, line 19: delete "sub. (4)," and substitute "sub. (4) or prohibited under".
 - **6.** Page 3, line 20: delete "date]," and substitute "date]. It is the intent of the legislature to create a mechanism whereby 2 or more political subdivisions may share in the operation, use, and funding of a nursing home or intermediate care facility without violating".

7. Page 3, line 20: delete "(d)," and substitute "(d)".
