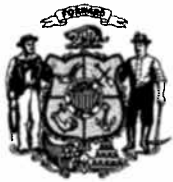

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 9: before “does not” insert “is a charge internal to the
- 3 commission and”.
- 4 **2.** Page 3, line 10: delete “to the commission”.
- 5 **3.** Page 3, line 11: after “par. (b)” insert “is a transfer of funds internal to the
- 6 commission and”.
- 7 **4.** Page 3, line 18: delete “nursing home”.
- 8 **5.** Page 3, line 19: delete “sub. (4),” and substitute “sub. (4) or prohibited
- 9 under”.
- 10 **6.** Page 3, line 20: delete “date],” and substitute “date]. It is the intent of the
- 11 legislature to create a mechanism whereby 2 or more political subdivisions may
- 12 share in the operation, use, and funding of a nursing home or intermediate care
- 13 facility without violating”.
