5 **2.** Page 7, line 5: delete that line, as affected by senate amendment 1, and
6 substitute:

7 "3. A person licensed as a real estate broker or salesperson under ch. 452."

8 **3.** Page 8, line 12: after "modernization" insert "or to perpetuate landmarks
9 under s. 59.74 (2)."
