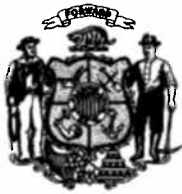

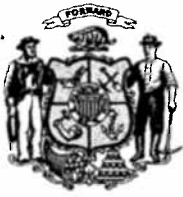
Under current law, a person under age 18 may not play bingo unless accompanied by his or her parent, guardian, or spouse. This bill provides that a person under age 18 may not play bingo unless accompanied by an adult who is a relative by blood, marriage, or adoption or by the person's guardian.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
