



2009 ASSEMBLY BILL 883

1 **AN ACT** *to renumber and amend* 48.562 (1); *to amend* 48.562 (2), 48.562 (3)
2 and 48.562 (4); and *to create* 48.562 (1g) and 48.562 (4m) of the statutes;
3 **relating to:** the duties of the Milwaukee Child Welfare Partnership Council.

Analysis by the Legislative Reference Bureau

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 48.562 (1) of the statutes is renumbered 48.562 (1m) and amended
5 to read:

6 48.562 **(1m)** ~~Formulate suggested~~ Recommend policies and plans for the
7 improvement of the child welfare system in Milwaukee County and ~~make~~ submit its
8 recommendations with respect to those policies and plans to the department and the
9 legislature under sub. (4m).

10 **SECTION 2.** 48.562 (1g) of the statutes is created to read:

1 48.562 **(1g)** Hold at least one public hearing each year at which the council
2 shall encourage public participation and solicit public input regarding the child
3 welfare system in Milwaukee County.

4 **SECTION 3.** 48.562 (2) of the statutes is amended to read:

5 48.562 **(2)** ~~Formulate suggested~~ Recommend measures for evaluating the
6 effectiveness of the child welfare system in Milwaukee County, including outcome
7 measures, and ~~make~~ submit its recommendations with respect to those measures to
8 the department ~~and the legislature~~ under sub. (4m).

9 **SECTION 4.** 48.562 (3) of the statutes is amended to read:

10 48.562 **(3)** ~~Formulate suggested~~ Recommend funding priorities for the child
11 welfare system in Milwaukee County and ~~make~~ submit its recommendations with
12 respect to those funding priorities to the department ~~and the legislature~~ under sub.
13 (4m).

14 **SECTION 5.** 48.562 (4) of the statutes is amended to read:

15 48.562 **(4)** Identify innovative public and private funding opportunities for the
16 child welfare system in Milwaukee County and ~~make~~ submit its recommendations
17 with respect to those funding opportunities to the department ~~and the legislature~~
18 under sub. (4m).

19 **SECTION 6.** 48.562 (4m) of the statutes is created to read:

20 48.562 **(4m)** Annually, submit a report of its recommendations under subs.
21 (1m) to (4) to the department, which within 60 days after receiving the report shall
22 prepare a response to those recommendations and transmit the report, together with
23 its response, to the governor and to the appropriate standing committees of the
24 legislature under s. 13.172 (3).
