## 2009 SENATE BILL 513

February 2, 2010 - Introduced by Senators WIRCH, VINEHOUT, RISSER, ERPENBACH, GROTHMAN and LEHMAN, cosponsored by Representatives BARCA, TOLES, RICHARDS, SOLETSKI, TURNER and FIELDS. Referred to Committee on Small Business, Emergency Preparedness, Technical Colleges, and Consumer Protection.

### *Analysis by the Legislative Reference Bureau*

Under current law, the owner of a life insurance policy that insures a person who has a catastrophic or life-threatening illness or condition, including AIDS or HIV infection, may sell the policy for an amount that is less than the expected death benefit under the policy in a transaction known as a viatical settlement. The person that makes the payment under the viatical settlement is known as a viatical settlement provider (provider) and must be licensed by the commissioner of insurance (commissioner). A person who, for a fee, offers or attempts to negotiate a viatical settlement between the owner of a life insurance policy and one or more providers is known as a viatical settlement broker (broker) and must be licensed by the commissioner. The commissioner may revoke, suspend, or refuse to renew a provider's or broker's license if the licensee misrepresented information in the application; engaged in fraudulent or dishonest practices or is shown to be untrustworthy or incompetent to act as a provider or broker; has been convicted of

a misdemeanor or felony involving fraud, deceit, or misrepresentation; violated Wisconsin law regarding viatical settlements; or if licensed as a provider, failed to meet the minimum settlement payment requirements or demonstrated a pattern of making unreasonable payments to policy owners. Every provider or broker must maintain records for all viatical settlements and make those records available to the commissioner for inspection.

Currently, if a policy owner who is seeking a viatical settlement has a catastrophic or life-threatening illness or condition and is the insured under the policy, the provider must obtain from the policy owner's physician a statement that the owner is of sound mind before entering into a viatical settlement contract with the policy owner. The provider must also obtain a written statement in which the policy owner consents to the viatical settlement contract; acknowledges his or her catastrophic or life-threatening illness or condition; releases his or her medical records to the provider; represents that he or she understands the viatical settlement contract, the benefits under the life insurance policy, and the relationship between the viatical settlement contract and the life insurance policy; acknowledges that he or she is entering into the viatical settlement contract freely and voluntarily; and affirms that he or she has received a recommendation from a provider or broker to seek financial advice regarding the effect of the viatical settlement on creditor claims, income taxes, and government benefits. Before the execution of the viatical settlement contract, the provider or broker must make disclosures, including that there may be alternatives to viatical settlements; that the policy owner should obtain financial advice; that some or all of the viatical settlement proceeds may be taxable or subject to the claims of creditors; that a viatical settlement may adversely affect the recipient's eligibility for government benefits; that the policy owner may rescind the viatical settlement contract; the frequency of and procedure for contacts by the provider or broker to determine the health status of the policy owner; the requirements imposed on the bank and escrow agent for the payment of viatical settlement proceeds; and that no beneficiary named by the policy owner will receive any insurance proceeds under the policy except under certain circumstances.

Current law requires every viatical settlement to be reasonable and sets minimum payment requirements based on the insured's life expectancy. The policy owner may rescind the contract within 30 days after entering into the contract or 15 days after receiving the viatical settlement proceeds, whichever is sooner. Under current law, a provider or broker may not discriminate in making a viatical settlement contract, unless the factor on which the provider or broker is discriminating affects the insured's life expectancy. A provider or broker may not pay or offer to pay a finder's fee to a person providing medical, legal, or financial planning services to a policy owner whose policy may become the subject of a viatical settlement. Current law limits the number of times the provider or broker may contact the insured based on the insured's life expectancy. A provider or broker may not solicit or accept as investors in a policy that is the subject of a viatical settlement contract persons who are in a position to influence the treatment of the insured's catastrophic or life-threatening illness or condition.

Current law requires advertising related to viatical settlements to be truthful and not misleading by fact or implication, in addition to other requirements.

This bill changes the terminology for the sale of a life insurance policy for an amount less than the death benefit but greater than the cash surrender value or accelerated death benefit under the policy to “life settlement.” The bill allows any individual in addition to one with catastrophic or life threatening illnesses or conditions to obtain a life settlement. Under the bill, a policy may be the subject of a life settlement within a five-year period commencing with the date of issuance of the policy only under certain conditions; one of these conditions is the terminal or chronic illness of the insured. The bill modifies the definitions of provider, broker, owner, and other terms related to life settlements. The bill also regulates certain aspects of the purchase of a policy that is the subject of a life settlement from a provider. In addition, the bill makes various changes related to life settlement laws, including the following:

1. The bill directs the commissioner to investigate each applicant for a provider’s or broker’s license and issue a license to an applicant if the applicant meets certain qualifications, including completion of an initial training course. The bill specifies the requirements for training of license applicants and of brokers and providers, including certain topics the training must cover. The bill adds the following to the bases for which the commissioner may suspend, revoke, or refuse to renew a license: that the licensee no longer meets the requirements for licensure; that the licensee, if a provider, has entered into any life settlement contract using a form that was not approved by the commissioner; that the licensee, if a provider, has failed to honor obligations in a life settlement contract; that the licensee, if a provider, has assigned or transferred a settled policy to a person other than a person specified in the bill; and that any officer, partner, member, or key management personnel has violated any of the requirements for life settlements in the bill. The commissioner may examine the business and affairs of licensed providers and brokers and applicants for licenses.

2. Under the bill, the insurer that issued the life insurance policy that was the subject of a life settlement is not responsible for an act or omission of a broker or provider unless the insurer received compensation for the placement of the life settlement contract from the broker or provider or from a purchaser of the life settlement contract.

3. The bill prohibits any person from using a life settlement contract form that has not been approved by the commissioner. In addition, no insurer may require any owner, insured, provider, or broker to sign a form that has not been approved by the commissioner for use in connection with life settlement contracts.

4. Under the bill, every licensed provider and broker must annually file with the commissioner a statement containing certain information, including any information that the commissioner prescribes by rule about a policy settled within five years of policy issuance. Licensees must keep certain records regarding life settlements and make those records available to the commissioner for inspection.

5. The bill adds disclosures to those that a provider or broker must make to the owner of the policy that is the subject of a life settlement, including that the broker

represents the owner exclusively and owes a fiduciary duty to the owner; that the funds from the life settlement will be sent to the owner within three business days after the provider has received acknowledgment that ownership of the policy has been transferred; that entering into a life settlement contract may cause forfeiture of other rights and benefits under the policy; and that medical, financial, or personal information may be disclosed to others to effect the life settlement. The provider must make certain disclosures to the owner, including the affiliation between the provider and the issuer of the policy to be settled; any affiliation or contractual arrangement between the provider and the purchaser; that, if the policy to be subject to a life settlement is a joint policy or involves family riders, the life settlement may result in the loss of coverage to the other family members; the dollar amount of the current death benefit; and that the funds from the life settlement will be escrowed with a third party. The broker must disclose to the owner the name, business address, and telephone number of the broker; a complete and accurate description of all offers, counteroffers, acceptances, and rejections related to the life settlement; the amount of the broker's compensation; the amount of the life settlement offer; and the percentage of the life settlement, if any, comprised by the broker's compensation. If the provider transfers ownership or changes the beneficiary of the policy the provider must communicate that in writing to the insured within 20 days. The provider must disclose certain information to the purchaser of a policy that is the subject of a life settlement. A broker or provider must disclose to the insurer a plan or transaction to originate, renew, continue, or finance a policy for the purpose of engaging in the business of life settlements at any time before, or during the first five years after, issuance of the policy.

6. The bill eliminates the minimum payment requirement for life settlements.

7. The bill requires that, before entering into a life settlement contract, the provider must obtain from the owner's physician, if the owner is the insured under the policy to be settled, a statement that the owner is under no constraint or undue influence to enter into a life settlement contract. Within 20 days of an owner's agreement to settle a policy, the provider must give written notice to the insurer that issued the policy that the policy will be the subject of a life settlement. The provider must also deliver to the insurer that issued the policy a copy of the insured's medical release, the owner's application for the life settlement, and a request for verification of coverage. The insurer must respond to a request for verification of coverage within 30 days after receiving the request and must indicate whether the insurer intends to investigate the validity of the contract or fraud related to the contract.

8. The bill retains the owner's ability to rescind a life settlement contract within the same time as under current law and provides that, if the insured dies during the period in which the owner may rescind a contract, the contract is automatically rescinded subject to repayment by the owner or owner's estate of all proceeds and payments made by the provider or a purchaser.

9. Under the bill, the owner, at the direction of the provider, must send the documents required to change the ownership of the policy directly to the escrow agent. Within three business days of the escrow agent receiving the documents, the provider must pay the proceeds of the life settlement to the escrow agent. If the

escrow agent does not pay the proceeds to the owner within three days after receiving acknowledgement that the ownership of the policy was transferred, the owner may void the life settlement contract until the proceeds are tendered to and accepted by the owner.

10. Within 30 days of receiving a request for a change of ownership or beneficiary of a policy, the insurer that issued a policy that is the subject of a life settlement must either acknowledge that the requested change has been made or specify the reasons why the requested change cannot be made.

11. Under the bill, a broker represents only the owner of the policy that will be the subject of a life settlement and owes a fiduciary duty to the owner.

12. The bill prohibits fraudulent life settlement acts, including acts or omissions that are committed by any person for the purpose of pecuniary gain; any acts that a person does in the furtherance of a fraud or to prevent the detection of a fraud; embezzlement, theft, misappropriation, or conversion from a life settlement provider, insurer, insured, owner, or any person engaged in the business of life settlements or insurance; recklessly dealing in a life settlement the subject of which is a policy that was obtained with intent to defraud; attempting, assisting, or conspiring to commit a fraudulent life settlement act; and stranger-originated life insurance. Stranger-originated life insurance is the initiation of a life insurance policy for the benefit of a third-party investor who has no insurable interest in the insured. The bill prohibits various other activities in connection with life settlements, including engaging in a transaction if the person knows that the intent is to avoid notice requirements; issuing or promoting the purchase of a life insurance policy for the purpose of settling the policy under a life settlement; and making a representation to the policy owner in connection with the sale or financing of a policy that the insurance is free unless that is provided in the policy. The bill requires a statement in all life settlement contracts, purchase agreements, and applications for a life settlement that any person who knowingly presents false information in an application for insurance, a life settlement, or a purchase agreement may be subject to civil and criminal penalties. The bill requires a person who engages in the business of life settlements and has knowledge or a reasonable belief that certain violations related to life settlements have been or will be committed to report that to the commissioner. Providers and brokers must have in place antifraud initiatives described in the bill.

13. Relating to advertisement of life settlements, the bill requires providers and brokers to maintain a system of control over the advertising of life settlements; requires that disclosures not be minimized or obscured; prohibits the omission of information or using misleading information about a benefit, covered loss, premium payable, or tax consequences; prohibits the use of the name or title of a life insurance company or policy unless the insurer has approved the advertisement; prohibits use of testimonials, appraisals, or analyses unless they are genuine; prohibits the implication that a life settlement contract or purchase agreement has been endorsed by an organization unless that is the fact; prohibits inaccurate statistical information; prohibits the disparagement of insurers, providers, brokers, producers, policies, services, or methods of marketing; requires the name of the provider or

broker to be in all advertisements; prohibits the use of materials that mislead policy owners or prospective purchasers into believing that the advertisement is connected with a government program or agency; prohibits exaggeration of the fact that the provider or broker holds a license so as to suggest that competing licensees are not licensed; prohibits emphasizing the dollar amounts available to an owner except as an average purchase price as a percent of the face value obtained by other policy owners in life settlements with the licensee during the previous six months; and imposes other requirements. The commissioner may require a provider or broker to submit advertising materials.

19           belief that it will be presented to or by a provider, broker, purchaser, financing entity,  
20           insurer, insurance producer, or any other person, false material information, or  
21           concealing material information, as part of, in support of, or concerning a fact  
22           material to an application for the issuance of a life settlement contract or a policy;  
23           the underwriting of a life settlement contract or a policy; a claim for payment or  
24           benefit under a life settlement contract or a policy; premiums paid on an insurance  
25           policy; payments and changes in ownership or beneficiary made in accordance with

1 the terms of a life settlement contract or a policy; the reinstatement or conversion of  
2 a policy; the solicitation, offer, effectuation, or sale of a life settlement contract or a

5 b. Employing any plan, device, scheme, or artifice to defraud in the business  
6 of life settlements.

7 c. Failing to disclose to an insurer, if the request for such disclosure has been

9 evaluation by any person or entity other than the insurer or its authorized  
10 representatives in connection with the issuance of the policy.

11 2. Any of the following acts that any person does, or permits its employees or

20           (j) 1. "Life settlement" means an agreement regarding the terms under which  
21 compensation or any thing of value will be paid, which compensation or thing of value  
22 is less than the expected death benefit of the policy but greater than the cash  
23 surrender value or accelerated death benefit available under the policy at the time  
24 of the application for the life settlement, in return for the owner's present or future

22           (w) “Stranger-originated life insurance” or “STOLI” means an act, practice,

25 origination, has no insurable interest in the insured. STOLI includes cases in which

2 for disapproval sufficiently explicitly that the licensee is provided reasonable  
3 guidance in reformulating its forms. The commissioner shall disapprove a life  
4 settlement contract form or disclosure statement form if the commissioner  
5 determines the form or provisions contained in the form fail to meet the  
6 requirements of this section, are unreasonable, are contrary to the interests of the  
7 public, or are otherwise misleading or unfair to the owner.

8 (b) No insurer may, as a condition of responding to a request for verification of  
9 coverage or in connection with the transfer of a policy under a life settlement  
10 contract, require that the owner, insured, provider, or broker sign any form,  
11 disclosure, consent, waiver, or acknowledgment that has not been expressly  
12 approved by the commissioner for use in connection with life settlement contracts in  
13 this state.

14 **(6) REPORTING REQUIREMENTS AND PRIVACY.** (a) 1. In addition to any other  
15 requirements, the annual statement that is filed with the commissioner shall specify  
16 the total number, aggregate face amount, and life settlement proceeds of policies  
17 settled during the immediately preceding calendar year, together with a breakdown  
18 of the information by policy issue year. The annual statement shall also include the  
19 names of the insurance companies whose policies have been settled and the brokers  
20 that were involved in settling the policies. Each provider shall provide in the annual  
21 statement any information about any policy settled within 5 years of policy issuance  
22 that the commissioner may prescribe by rule.

23 2. Information provided in the annual statement shall be limited to those  
24 transactions in which the owner is a resident of this state and shall not include  
25 individual transaction data regarding the business of life settlements or information

1 that there is a reasonable basis to believe could be used to identify the owner or the  
2 insured.

3 3. Every provider that willfully fails to file an annual statement as required in  
4 this section, or willfully fails to reply within 30 days to a written inquiry by the  
5 commissioner regarding the annual statement, shall be subject to a forfeiture under  
6 s. 601.64 (3) (c) and to license suspension, revocation, or nonrenewal.

7 (b) A provider, broker, insurance company, producer, information bureau,  
8 rating agency or company, or any other person with actual knowledge of an insured's  
9 identity, shall not disclose the identity of an insured or information that there is a  
10 reasonable basis to believe could be used to identify the insured or the insured's  
11 financial or medical information to any other person unless one of the following  
12 applies:

13 1. The disclosure is necessary to effect a life settlement contract between the  
14 owner and a provider, and the owner and insured have provided prior written  
15 consent to the disclosure.

16 2. The disclosure is necessary to effectuate a sale of life settlement contracts,  
17 or interests in life settlement contracts, as investments, if the sale is conducted in  
18 accordance with applicable state and federal securities law and if the owner and the  
19 insured have both provided prior written consent to the disclosure.

20 3. The disclosure is provided in response to an investigation or examination by  
21 the commissioner or any other governmental officer or agency or pursuant to the  
22 requirements of sub. (15).

23 4. The disclosure is a term or condition of the transfer of a policy by one provider  
24 to another provider. In such cases, the receiving provider shall be required to comply  
25 with the confidentiality requirements of this subsection.

1           5. The disclosure is necessary to allow the provider or broker or their  
2 authorized representatives to make contacts for the purpose of determining health  
3 status. For the purposes of this subdivision, “authorized representative” does not  
4 include any person who has or may have any financial interest in the life settlement  
5 contract other than a provider, broker, financing entity, related provider trust, or  
6 special purpose entity. A provider or broker shall require its authorized  
7 representative to agree in writing to adhere to the privacy provisions of this  
8 subsection.

9           6. The disclosure is required to purchase stop loss coverage.

10           (c) Nonpublic personal information solicited or obtained in connection with a  
11 proposed or actual life settlement contract shall be subject to all applicable laws of  
12 this state relating to confidentiality of nonpublic personal information.

13           **(7) EXAMINATIONS AND ALTERNATIVES.** (a) The commissioner may, whenever the  
14 commissioner determines it is necessary in order to be informed about any matter  
15 related to the enforcement of this section, examine the business and affairs of any  
16 licensee or applicant for a license, under the provisions of ss. 601.43 to 601.45.

17           (b) The commissioner shall consider names and individual identification data  
18 for all owners, purchasers, and insureds private and confidential information and  
19 shall not disclose names or identification data unless the disclosure is to another  
20 regulator or is required by law.

21           (c) 1. A person required to be licensed by this section shall for 5 years retain,  
22 and make available to the commissioner for inspection at all reasonable times in  
23 accordance with s. 601.42, copies of all of the following:

24           a. Proposed, offered, or executed life settlement contracts, purchase  
25 agreements, underwriting documents, policy forms, and applications from the date

1 of the proposal, offer, or execution of a life settlement contract or purchase  
2 agreement, whichever is later.

3 b. All checks, drafts, or other evidence and documentation related to the  
4 payment, transfer, deposit, or release of funds from the date of the financing  
5 transaction, life settlement, or purchase agreement.

6 c. All other records and documents related to the requirements of this section.

7 2. Records required to be retained under subd. 1. must be legible and complete  
8 and may be retained in paper, photograph, microprocess, magnetic, mechanical or  
9 electronic media, or by any process that accurately reproduces or forms a durable  
10 medium for reproduction of a record.

11 **(8) DISCLOSURES TO OWNER; DISCLOSURE TO INSURED.** (a) 1. With each application  
12 for a life settlement, a provider or broker shall disclose to the owner, in a separate  
13 document that is signed by the owner and the provider or broker, at least all of the  
14 following information no later than the time the application for the life settlement  
15 is signed by all parties:

16 a. That there are possible alternatives to life settlement contracts, including  
17 any accelerated death benefits or policy loans offered under the owner's policy.

18 b. That the broker represents exclusively the owner, and not the insurer or the  
19 provider, and owes a fiduciary duty to the owner, including the duty to act according  
20 to the owner's instructions and in the best interest of the owner.

21 c. That some or all of the proceeds of the life settlement may be taxable under  
22 federal income tax and state franchise and income tax laws, and the owner should  
23 seek assistance from a professional tax advisor.

24 d. That proceeds from a life settlement may be subject to the claims of creditors.

1 e. That receipt of proceeds from a life settlement may adversely affect the  
2 owner's eligibility for Medical Assistance or other government benefits or  
3 entitlements, and the owner should seek advice from the appropriate government  
4 agencies.

5 f. That the owner has a right to rescind a life settlement contract before the  
6 earlier of 30 calendar days after the date upon which the life settlement contract is  
7 executed by all parties or 15 calendar days after the life settlement proceeds have  
8 been paid to the owner, as provided in sub. (11) (d). Rescission, if exercised by the  
9 owner, is effective only if both notice of the rescission is given and the owner repays  
10 all proceeds and any premiums, loans, and loan interest paid on account of the life  
11 settlement within the rescission period. If the insured dies during the rescission  
12 period, the life settlement contract is rescinded, subject to repayment by the owner  
13 or the owner's estate to the provider or purchaser of all life settlement proceeds, and  
14 any premiums, loans, and loan interest that have been paid by the provider or  
15 purchaser, which shall be repaid within 60 calendar days of the death of the insured.

16 g. That funds will be sent to the owner within 3 business days after the provider  
17 has received the insurer's or group administrator's written acknowledgement that  
18 ownership of the policy or interest in the certificate has been transferred and the  
19 beneficiary has been designated.

20 h. That entering into a life settlement contract may cause other rights or  
21 benefits, including conversion rights and waiver of premium benefits that may exist  
22 under the policy, to be forfeited by the owner, and the owner should seek assistance  
23 from a professional financial advisor.

24 i. The language: "All medical, financial, or personal information solicited or  
25 obtained by a provider or broker about an insured, including the insured's identity

1 or the identity of family members, a spouse, or a significant other, may be disclosed  
2 as necessary to effect the life settlement between the owner and provider. If you are  
3 asked to provide this information, you will be asked to consent to the disclosure. The  
4 information may be provided to someone who buys the policy or provides funds for  
5 the purchase. You may be asked to renew your permission to share information every  
6 2 years.”

7 j. That, following execution of a life settlement contract, the insured may be  
8 contacted for the purpose of determining the insured’s health status and to confirm  
9 the insured’s residential or business street address and telephone number, or as  
10 otherwise allowed in this section. This contact shall be limited to once every 3  
11 months if the insured has a life expectancy of more than one year and no more than  
12 once per month if the insured has a life expectancy of one year or less. All such  
13 contacts with the insured shall be made only by a provider licensed in the state in  
14 which the owner resided at the time of the life settlement, or by an authorized  
15 representative of the provider.

16 2. At the time the disclosures in subd. 1. are provided, the broker or provider  
17 shall provide to the owner a brochure describing the process of life settlements that  
18 is approved by the commissioner.

19 (b) A provider shall disclose to the owner, either conspicuously displayed in the  
20 life settlement contract or in a separate document signed by the owner, at least all  
21 of the following information no later than the date the life settlement contract is  
22 signed by all parties:

23 1. The affiliation, if any, between the provider and the issuer of the policy to be  
24 settled.

25 2. The name, business address, and telephone number of the provider.

1           3. Any affiliation or contractual arrangements between the provider and the  
2 purchaser.

3           4. If a policy to be settled has been issued as a joint policy or involves family  
4 riders or any coverage of a life other than that of the insured under the policy to be  
5 settled, the possible loss of coverage on the other lives under the policy, together with  
6 a statement advising the owner to consult with the insurer issuing the policy for  
7 advice concerning the proposed life settlement.

8           5. The dollar amount of the current death benefit that will be payable to the  
9 provider under the policy. If known, the provider shall also disclose the availability  
10 of any additional guaranteed insurance benefits, the dollar amount of any accidental  
11 death and dismemberment benefits under the policy, and the extent to which the  
12 owner's interest in those benefits will be transferred as a result of the life settlement  
13 contract.

14           6. That the funds will be escrowed with an independent 3rd party during the  
15 transfer process; the name, business address, and telephone number of the  
16 independent 3rd party escrow agent; and that the owner may inspect or receive  
17 copies of the relevant escrow or trust agreements or documents.

18           (c) A broker shall disclose to the owner, either conspicuously displayed in the  
19 life settlement contract or in a separate document signed by the owner, at least all  
20 of the following information no later than the date the life settlement contract is  
21 signed by all parties:

22           1. The name, business address, and telephone number of the broker.

23           2. A full, complete, and accurate description of all offers, counteroffers,  
24 acceptances, and rejections related to the proposed life settlement contract.

1           3. A written statement of any affiliation or contractual arrangement between  
2 the broker and any person making an offer in connection with the proposed life  
3 settlement contract.

4           4. The amount of the broker's compensation, including anything of value paid  
5 or given to the broker for the placement of the policy.

6           5. If any portion of the broker's compensation is taken from a proposed life  
7 settlement, the total amount of the life settlement offer and the percentage of the life  
8 settlement comprised by the broker's compensation.

9           (d) If the provider transfers ownership or changes the beneficiary of the policy,  
10 the provider shall communicate in writing the change in ownership or beneficiary to  
11 the insured within 20 days after the change.

12           **(9) DISCLOSURES TO PURCHASER.** (a) 1. A provider shall disclose to a purchaser,  
13 conspicuously displayed in the purchase agreement or in a separate document signed  
14 by the purchaser and provider, at least all of the following information prior to the  
15 date the purchase agreement is signed by all parties:

16           a. That the purchaser will receive no returns, including dividends and interest,  
17 until the insured dies and a death claim payment is made.

18           b. That the actual rate of return on a life settlement contract is dependent upon  
19 an accurate projection of the insured's life expectancy and the actual date of the  
20 insured's death and that an annual guaranteed rate of return is not determinable.

21           c. That the settled policy should not be considered a liquid purchase since it is  
22 impossible to predict the exact timing of its maturity and the funds are not available  
23 until the death of the insured and that there is no established secondary market for  
24 resale of a settled policy by the purchaser.

1           d. That the purchaser may lose all benefits or may receive substantially  
2 reduced benefits if the insurer goes out of business during the contract term of the  
3 life settlement investment.

4           e. That the purchaser is responsible for payment of the insurance premiums  
5 or other costs related to the policy, if required by the terms of the purchase  
6 agreement, even if the insured returns to health, and that the payments may reduce  
7 the purchaser's return. If a party other than the purchaser is responsible for the  
8 payment, the name and address of the party responsible for payment shall be  
9 disclosed.

10          f. The amount of the premiums, if applicable.

11          g. The name, business address, and telephone number of the independent 3rd  
12 party providing escrow services and any relationship to the broker.

13          h. The amount of any trust fees or expenses to be charged the purchaser.

14          i. Whether the purchaser is entitled to a refund of all or part of the purchaser's  
15 investment under the purchase agreement if the policy is later determined to be null  
16 and void.

17          j. That group policies may contain limitations or caps in the conversion rights,  
18 that additional premiums may have to be paid if the policy is converted, the name  
19 of the party responsible for payment of any additional premiums, and that if a group  
20 policy is terminated and replaced by another group policy, there may be no right to  
21 convert the original coverage.

22          k. The risks associated with policy contestability, including the risk that the  
23 purchaser will have no claim or only a partial claim to death benefits should the  
24 insurer rescind the policy within the contestability period.

1           L. Whether the purchaser will be the owner of the policy in addition to being  
2 the beneficiary, and if the purchaser is the beneficiary only and not also the owner,  
3 the special risks associated with that status, including the risk that the beneficiary  
4 may be changed or the premium may not be paid.

5           m. The experience and qualifications of the person who determines the life  
6 expectancy of the insured, including in-house staff, independent physicians, and  
7 specialty firms that weigh medical and actuarial data, the information the projection  
8 is based on, and the relationship of the projection maker to the provider, if any.

9           2. At the time the disclosures in subd. 1. are provided, the provider shall provide  
10 to the purchaser a brochure approved by the commissioner describing the process of  
11 the purchase of a settled policy.

12           (b) A provider shall disclose to a purchaser, in a document signed by the  
13 purchaser and provider, at least all of the following no later than at the time of the  
14 assignment, transfer, or sale of all of or an interest in a policy:

15           1. All the life expectancy certifications obtained by the provider in the process  
16 of determining the price to be paid to the owner.

17           2. Whether the premium payments or other costs related to the policy have  
18 been escrowed and, if so, the date upon which the escrowed funds will be depleted,  
19 whether the purchaser will be responsible for payment of premiums after the  
20 depletion of escrowed funds, and the amount of the premium if the purchaser is  
21 responsible for payment.

22           3. Whether the premiums or other costs related to the policy have been waived  
23 and, if so, whether the purchaser will be responsible for payment of the premiums  
24 if the insurer that issued the policy terminates the waiver after purchase and, if so,  
25 the amount of the premiums.

1           4. Whether the type of policy offered or sold is whole life, term life, universal  
2 life, a group policy, or another type of policy, any additional benefits contained in the  
3 policy, and the current status of the policy.

4           5. If the policy is term insurance, the special risks associated with term  
5 insurance including the purchaser's responsibility for additional premiums if the  
6 owner continues the term policy at the end of the current term.

7           6. Whether the policy is contestable.

8           7. Whether the insurer that issued the policy has any additional rights that  
9 could negatively affect or extinguish the purchaser's rights under the purchase  
10 agreement and, if so, what those rights are and under what conditions those rights  
11 are activated.

12           8. The name and address of the person responsible for monitoring the insured's  
13 condition, how often the monitoring is done, how the date of death is determined, and  
14 how and when the information will be transmitted to the purchaser.

15           **(10) DISCLOSURE TO INSURER.** Before initiating a plan, transaction, or series of  
16 transactions, a broker or provider shall fully disclose to the insurer a plan,  
17 transaction, or series of transactions to which the broker or provider is a party to  
18 originate, renew, continue, or finance a policy with the insurer for the purpose of  
19 engaging in the business of life settlements at any time prior to, or during the first  
20 5 years after, issuance of the policy.

21           **(11) GENERAL REQUIREMENTS.** (a) 1. Before entering into a life settlement  
22 contract, a provider shall obtain all of the following:

23           a. If the owner is the insured, a written statement from a licensed attending  
24 physician that the owner is of sound mind and under no constraint or undue  
25 influence to enter into a life settlement contract.

1           b. A document in which the insured consents to the release of his or her medical  
2 records to a licensed provider, licensed broker, and the insurer that issued the policy  
3 covering the life of the insured.

4           2. Within 20 days after an owner executes documents necessary to transfer any  
5 rights under a policy or within 20 days after the owner enters any agreement, option,  
6 promise, or any other form of understanding, express or implied, to settle the policy,  
7 the provider shall give written notice to the insurer that issued the policy that the  
8 policy has or will become a settled policy.

9           3. The provider shall deliver a copy of the medical release required under subd.  
10 1. b., a copy of the owner's application for the life settlement contract, the notice  
11 required under subd 2., and a request for verification of coverage to the insurer that  
12 issued the policy that is the subject of the life settlement. The provider shall use a  
13 form created by the National Association of Insurance Commissioners for  
14 verification of coverage unless the commissioner develops and approves another  
15 form.

16           4. The insurer shall respond to a request for verification of coverage that is  
17 submitted on an approved form by a provider or broker within 30 calendar days after  
18 the date the request is received and shall indicate whether, based on the medical  
19 evidence and documents provided, the insurer intends to pursue an investigation  
20 regarding the validity of the insurance contract or possible fraud. The insurer shall  
21 accept a request for verification of coverage made on a form created by the National  
22 Association of Insurance Commissioners or any other form approved by the  
23 commissioner, and shall accept an original, facsimile, or electronic copy of the  
24 request and any accompanying signed authorization.

1           5. Before or at the time of execution of the life settlement contract, the provider  
2 shall obtain a witnessed document in which the owner does all of the following:

3           a. Consents to the life settlement contract.

4           b. Represents that he or she has a complete understanding of the life settlement

6           c. Represents that he or she has a complete understanding of the benefits of the  
7 policy.

8           d. Acknowledges that he or she is entering into the life settlement contract  
9 freely and voluntarily.

10          e. If applicable, acknowledges that the insured has a terminal or chronic illness  
11 and that the terminal or chronic illness or condition was diagnosed after the policy  
12 was issued.

13          6. If a broker performs any of the activities required in subd. 1., 2., 3., or 5., the  
14 provider shall be considered to have performed that activity.

15          (b) All medical information solicited or obtained by any licensee shall be subject  
16 to the applicable provisions of state law relating to confidentiality of medical  
17 information, including s. 610.70.

18          (c) All life settlement contracts entered into in this state shall provide the  
19 owner with an absolute right to rescind the contract before the earlier of 30 calendar  
20 days after the date on which the life settlement contract is executed by all parties or  
21 15 calendar days after the life settlement proceeds have been sent to the owner as  
22 provided in par. (d). Rescission by the owner may be conditioned upon the owner both  
23 giving notice and repaying to the provider, within the rescission period, all proceeds  
24 of the settlement and any premiums, loans, and loan interest paid by or on behalf of  
25 the provider in connection with or as a consequence of the life settlement. If the

1 insured dies during the rescission period, the life settlement contract is rescinded,  
2 subject to repayment, within 60 calendar days after the death of the insured, by the  
3 owner or the owner's estate to the provider or purchaser of all life settlement  
4 proceeds and any premiums, loans, and loan interest that have been paid by the  
5 provider or purchaser. If a life settlement contract is rescinded under this  
6 paragraph, ownership of the policy shall revert to the owner or the owner's estate if  
7 the owner is deceased, irrespective of any transfer of ownership of the policy by the  
8 owner, provider, or any other person. In the event of any rescission, if the provider  
9 has paid commissions or other compensation to a broker in connection with the  
10 rescinded life settlement contract, the broker shall refund the commissions and  
11 compensation to the provider within 5 business days following receipt of written  
12 demand from the provider, which demand shall be accompanied by the applicable  
13 document initiating the rescission within the rescission period, either the owner's  
14 notice of rescission or the notice of death of the insured.

15 (d) The provider shall instruct the owner to send the executed documents  
16 required to effect the change in ownership, assignment, or change in beneficiary  
17 directly to the independent escrow agent. Within 3 business days after the date the  
18 independent escrow agent receives the documents, or after the date the provider  
19 receives the documents if the owner erroneously provides the documents directly to  
20 the provider, the provider shall pay or transfer the proceeds of the life settlement into  
21 an escrow or trust account that is maintained in a state or federally chartered  
22 financial institution whose deposits are insured by the Federal Deposit Insurance  
23 Corporation and managed by an independent trustee or escrow agent. Upon  
24 payment of the life settlement proceeds into the escrow account, the independent  
25 escrow agent shall deliver the original change in ownership, assignment, or change

1 in beneficiary form to the provider or related provider trust or other designated  
2 representative of the provider. Upon the escrow agent's receipt of acknowledgement  
3 of the properly completed transfer of ownership, assignment, or designation of  
4 beneficiary from the insurer, the independent escrow agent shall pay the life  
5 settlement proceeds to the owner.

6 (e) Failure to tender the life settlement proceeds to the owner within the time  
7 set forth in the disclosure under sub. (8) (a) 1. g., renders the life settlement contract  
8 voidable by the owner for lack of consideration until the time the proceeds are  
9 tendered to and accepted by the owner. Funds are sent by a provider to an owner as  
10 of the date that the escrow agent either releases funds for wire transfer to the owner  
11 or places a check for delivery to the owner via the U.S. postal service or other  
12 nationally recognized delivery service.

13 (f) For the purpose of determining the health status of the insured after the life  
14 settlement has occurred, only the provider or broker licensed in this state or a person  
15 it authorizes may contact the insured. Contact with the insured shall be limited to  
16 once every 3 months for an insured with a life expectancy of more than one year, and  
17 to no more than once per month for an insured with a life expectancy or one year or  
18 less. The provider or broker shall explain the procedure for the contacts to the owner  
19 at the time the life settlement contract is entered into. The limitations in this  
20 paragraph do not apply to any contacts with an insured for reasons other than  
21 determining the insured's health status. Providers and brokers shall be responsible  
22 for the actions of a person they authorize to make the contact.

23 **(12) PROHIBITED CONTRACTS; REQUIRED FORM; ACKNOWLEDGEMENT; FIDUCIARY DUTY.**

24 (a) No person may enter into a life settlement contract at any time before the  
25 application or issuance of a policy that is the subject of a life settlement contract or

1 within a 5-year period commencing with the date of issuance of the policy unless any  
2 of the following conditions have been met:

3 1. The owner certifies to the provider that, within the 5-year period, the policy  
4 was issued upon the owner's exercise of conversion rights arising out of a group or  
5 individual policy, provided the total of the time covered under the conversion policy  
6 plus the time covered under the prior policy is at least 60 months. The time covered  
7 under the group policy shall be calculated without regard to any change in insurance  
8 carriers, if the coverage has been continuous and under the same group sponsorship.

9 2. The owner submits independent evidence to the provider that any of the  
10 following conditions have been met within the 5-year period:

11 a. The owner or insured is terminally or chronically ill.

12 b. The owner's spouse or child dies.

13 c. The owner divorces his or her spouse.

14 d. The owner retires from full-time employment.

15 e. The owner becomes physically or mentally disabled and a physician  
16 determines that the disability prevents the owner from maintaining full-time  
17 employment.

18 f. A final order, judgment, or decree is entered by a court of competent  
19 jurisdiction, on the application of a creditor of the owner, adjudicating the owner  
20 bankrupt or insolvent, approving a petition seeking reorganization of the owner, or  
21 appointing a receiver, trustee, or liquidator to all or a substantial part of the owner's  
22 assets.

23 g. The sole beneficiary of the policy is a family member of the owner and the  
24 beneficiary dies.

1           h. The owner is a charitable organization with an insurable interest that has  
2 received from the federal Internal Revenue Service a determination letter that is  
3 currently in effect stating that the charitable organization is described in section 501  
4 (c) (3) of the Internal Revenue Code and is exempt from federal income taxation  
5 under section 501 (a) of the Internal Revenue Code.

6           i. The owner or insured disposes of ownership interests in a closely held  
7 corporation pursuant to the terms of a buyout or other similar agreement in effect  
8 at the time the policy was initially issued.

9           j. Other circumstances exist that are established as eligible exemptions by the  
10 commissioner by rule, including substantial adverse financial circumstances or  
11 other factors substantially affecting the owner.

12           3. The owner certifies to the provider that the owner is entering into a life  
13 settlement contract more than 2 years after the date of issuance of a policy and, with  
14 respect to the policy, at all times before the date that is 2 years after policy issuance  
15 all of the following conditions are met:

16           a. Policy premiums are funded exclusively with unencumbered assets,  
17 including an interest in the policy being financed only to the extent of its net cash  
18 surrender value, provided by, or full recourse liability incurred by, the owner or a  
19 person described in sub. (1) (j) 2. e.

20           b. There is no agreement or understanding with any other person to guarantee  
21 any liability or to purchase, or stand ready to purchase, the policy, including through  
22 an assumption or forgiveness of a loan.

23           c. Neither the insured nor the policy has been evaluated for settlement.

24           (b) Copies of the independent evidence described in par. (a) 2. and documents  
25 required by sub. (11) (a) shall be submitted to the insurer when the provider entering

1 into a life settlement contract with an owner submits a request to the insurer for  
2 verification of coverage. The provider shall submit, along with the copies, a letter of  
3 attestation from the provider that the copies are true and correct copies of the  
4 documents received by the provider.

5 (c) If the provider submits to the insurer a copy of the owner's certification  
6 under par. (a) 1. or 3. or independent evidence under par. (a) 2. when the provider  
7 submits a request to the insurer to effect the transfer of the policy to the provider,  
8 the copy conclusively establishes that the life settlement contract satisfies the  
9 requirements of this subsection and the insurer shall timely respond to the request.

10 (d) No insurer may, as a condition of responding to a request for verification of  
11 coverage or effecting the transfer of a policy pursuant to a life settlement contract,  
12 require that the owner, insured, provider, or broker sign any form, disclosure,  
13 consent, or waiver that has not been expressly approved by the commissioner for use  
14 in connection with life settlement contracts in this state.

15 (e) Upon receipt of a properly completed request for change of ownership or  
16 beneficiary of a policy, the insurer shall respond in writing within 30 calendar days  
17 with acknowledgement confirming that the change has been effected or specifying  
18 the reasons why the requested change cannot be processed.

19 (f) A broker represents only the owner and owes a fiduciary duty to the owner  
20 to act according to the owner's instructions and in the best interest of the owner,  
21 notwithstanding the manner in which the broker is compensated.

22 **(13) PROHIBITED PRACTICES AND CONFLICTS OF INTEREST.** (a) No person may enter  
23 into a life settlement contract if the person knows or reasonably should have known  
24 that the policy that is the subject of the life settlement contract was obtained by  
25 means of a false, deceptive, or misleading application for the policy.

1 (b) No person may engage in any transaction, practice, or course of business if  
2 the person knows or reasonably should know that the intent is to avoid the notice  
3 requirements of this section.

4 (c) No person may engage in any fraudulent act or practice in connection with  
5 any transaction relating to any life settlement involving an owner.

6 (d) No person may issue, solicit, market, or otherwise promote the purchase of  
7 a policy for the primary purpose of or with a primary emphasis on settling the policy.

8 (e) No person may enter into a premium finance agreement with any person  
9 or agency, or any person affiliated with such person or agency, pursuant to which the  
10 person who is providing premium financing receives any proceeds, fees, or other  
11 consideration, directly or indirectly, from the policy or owner of the policy or any other  
12 person with respect to the premium finance agreement or any life settlement  
13 contract or other transaction related to the policy that is in addition to the amounts  
14 required to pay the principal, interest, and service charges related to policy  
15 premiums pursuant to the premium finance agreement or subsequent sale of the  
16 agreement. Any payments, charges, fees, or other amounts in addition to the  
17 amounts required to pay the principal, interest, and service charges related to policy  
18 premiums paid under the premium finance agreement shall be remitted to the  
19 original owner of the policy or to the owner's estate if the owner is not living at the  
20 time of the determination of the overpayment.

21 (f) With respect to any life settlement contract or policy, no broker may  
22 knowingly solicit an offer from, effectuate a life settlement with, or make a sale to  
23 any provider, purchaser, financing entity, or related provider trust that is controlling,  
24 controlled by, or under common control with the broker unless the relationship is  
25 disclosed to the owner.

1           (g) With respect to any life settlement contract or policy, no provider may  
2 knowingly enter into a life settlement contract with an owner, if, in connection with  
3 the life settlement contract, anything of value will be paid to a broker that is  
4 controlling, controlled by, or under common control with the provider or the  
5 purchaser, financing entity, or related provider trust that is involved in the life  
6 settlement contract unless the relationship is disclosed to the owner.

7           (h) No life settlement promotional, advertising, or marketing materials may  
8 represent that the insurance is “free” for any period of time, or include any reference  
9 that would cause an owner to reasonably believe that the insurance is free for any  
10 period of time.

11           (i) No producer, insurer, broker, or provider may make any statement or  
12 representation to an applicant or policyholder in connection with the sale or  
13 financing of a policy to the effect that the insurance is free or without cost to the  
14 policyholder for any period of time unless provided in the policy.

15           **(14) ADVERTISEMENTS OF LIFE SETTLEMENT CONTRACTS AND PURCHASE AGREEMENTS.**

16           (a) This subsection applies to any advertising of life settlement contracts, purchase  
17 agreements, or related products or services intended for dissemination in this state,  
18 including Internet advertising viewed by persons located in this state.

19           (b) If disclosure requirements are established by federal regulation, this  
20 subsection shall be interpreted so as to minimize or eliminate conflict with federal  
21 regulation.

22           (c) The commissioner may require a broker or provider to submit advertising  
23 material at any time.

24           (d) Every licensee shall establish and maintain a system of control over the  
25 content, form, and method of dissemination of all advertisements of its life

1 settlement contracts, products, and services. All advertisements, regardless who  
2 wrote, created, designed, or presented the advertisement, shall be the responsibility  
3 of the licensee and the person who created or presented the advertisement. The  
4 system of control shall include regular routine notification of the requirements and  
5 procedures for approval prior to use of any advertisements not furnished by the  
6 licensee, at least once a year, to producers, brokers, and others authorized by the  
7 licensee who disseminate advertisements.

8 (e) Advertisements shall be truthful and not misleading in fact or by  
9 implication. The form and content of an advertisement of a life settlement contract  
10 or purchase agreement, product, or service shall be sufficiently complete and clear  
11 so as to avoid deception. The advertisement may not have the capacity or tendency  
12 to mislead or deceive. The commissioner shall determine whether an advertisement  
13 has the capacity or tendency to mislead or deceive from the overall impression that  
14 the advertisement may be reasonably expected to create upon a person of average  
15 education or intelligence within the segment of the public to which it is directed.

16 (f) Disclosures that are required under this subsection may not be minimized,  
17 rendered obscure, presented in an ambiguous fashion, or intermingled with the text  
18 of the advertisement so as to be confusing or misleading.

19 (g) An advertisement may not do any of the following:

20 1. Omit material information or use words, phrases, statements, references, or  
21 illustrations if the omission or use has the capacity, tendency, or effect of misleading  
22 or deceiving an owner, purchaser, or prospective purchaser as to the nature or extent  
23 of any benefit, covered loss, premium payable, or state or federal tax consequences.

24 A misleading statement is not remedied by any of the following:

1           a. Making the life settlement contract or purchase agreement available for  
2 inspection prior to consummation of the sale.

3           b. Offering to refund payment if the owner is not satisfied.

4           c. Including in the life settlement contract or purchase agreement a “free look”

6           2. Use the name or title of a life insurance company or a policy unless the  
7 advertisement has been approved by the insurer.

8           3. Represent that premium payments will not be required on the policy that is  
9 the subject of a life settlement contract or purchase agreement in order to maintain  
10 the policy unless that is the fact.

11          4. State or imply that interest charged on an accelerated death benefit or loan  
12 is unfair, inequitable, or, in any manner, an incorrect or improper practice.

13          5. Use the words “free,” “no cost,” “without cost,” “no additional cost,” “at no  
14 extra cost,” or similar words or phrases with respect to any benefit or services, unless  
15 true. An advertisement may specify the charge for a benefit or service or may state  
16 that a charge is included in the payment or use other appropriate language.

17          6. Use testimonials, appraisals, analyses, or endorsements in advertisements  
18 unless they are genuine; represent the current opinion of the author; are applicable  
19 to the life settlement contract or purchase agreement, product, or service advertised;  
20 and are reproduced with sufficient completeness to avoid misleading or deceiving  
21 prospective owners or purchasers as to the nature or scope of the testimonial,  
22 appraisal, analysis, or endorsement. Any financial interest in or benefit received  
23 from the licensee by the person making a testimonial, appraisal, or analysis, directly  
24 or indirectly, shall be prominently disclosed in the advertisement. If an endorsement  
25 refers to benefits received under a life settlement contract or purchase agreement,

1 the licensee shall retain all pertinent information forming a basis of the endorsement  
2 for a period of 5 years following its use.

3 7. State or imply that a life settlement contract or purchase agreement, benefit,  
4 or service has been approved or endorsed by a group, society, association, or other  
5 organization unless that is the fact and unless any relationship between the  
6 organization and the licensee is disclosed. If the entity making the endorsement is  
7 owned, controlled, or managed by the licensee, or receives any payment or other  
8 consideration from the licensee for making an endorsement or testimonial, that fact  
9 must be disclosed in the advertisement.

10 8. Contain statistical information unless the information accurately reflects  
11 recent and relevant facts. An advertisement shall identify the source of all statistics  
12 used in the advertisement.

13 9. Disparage insurers, providers, brokers, producers, policies, services, or  
14 methods of marketing.

15 10. Omit the name of the actual licensee from any advertisement. No  
16 advertisement may use a trade name, group designation, name of the parent  
17 company of a licensee, name of a division of a life settlement licensee, service mark,  
18 slogan, symbol, or other device or reference if the advertisement would have the  
19 capacity or tendency to mislead or deceive as to the true identity of the licensee or  
20 to create the impression that any entity other than the licensee would have any  
21 responsibility for the financial obligation under a life settlement contract or  
22 purchase agreement.

23 11. Use any combination of words, symbols, or physical materials that by the  
24 their content, phraseology, shape, color, or other characteristics are so similar to a  
25 combination of words, symbols, or physical materials used by a government program

1 or agency that they tend to mislead or deceive prospective owners or purchasers into  
2 believing the advertisement is in some manner connected with a government  
3 program or agency.

4 12. Exaggerate the fact that a licensee under this section is licensed in the state  
5 where the advertisement appears or suggest or imply that competing licensees may  
6 not be so licensed. An advertisement may ask the audience to consult the licensee's  
7 Web site or contact the office of the commissioner for licensing requirements and the  
8 status of a license.

9 13. Create the impression, directly or indirectly, that a licensee; its business  
10 practices or methods of operation; the merits desirability or advisability of any life  
11 settlement contract or purchase agreement; or any life insurance company are  
12 recommended, approved, or endorsed by any government entity.

13 14. Emphasize the speed with which the settlement will occur, except that the  
14 advertisement may disclose the average time from the completion of the application  
15 to the date of offer and from the acceptance of the offer to receipt of the settlement  
16 funds by the owner.

17 15. Emphasize the dollar amounts available to an owner, except that the  
18 advertisement may disclose the average purchase price as a percent of the face value  
19 obtained by owners contracting with the licensee during the prior 6 months.

20 (h) The name of the licensee shall be clearly identified in all advertisements  
21 about the licensee or its life settlement contracts, purchase agreements, products, or  
22 services. If any specific life settlement contract or purchase agreement of a licensee  
23 is advertised, the contract or agreement shall be identified either by form number  
24 or other appropriate description. If an application is part of the advertisement, the  
25 name of the provider shall be shown on the application.

1           **(15) FRAUD PREVENTION AND CONTROL; FRAUDULENT LIFE SETTLEMENT ACTS.**

2           (a) No person may commit a fraudulent life settlement act.

3           (b) No person may knowingly or intentionally interfere with the enforcement  
4 of this subsection or sub. (13) or investigations of suspected or actual violations of this  
5 subsection or sub. (13).

6           (c) No person in the business of life settlements may knowingly or intentionally  
7 permit any person convicted of a felony involving dishonesty or breach of trust to

9           (d) 1. Life settlement contracts, purchase agreements, and applications for life  
10 settlements, regardless of the form of transmission, shall contain the following  
11 statement or a substantially similar statement: “Any person who knowingly  
12 presents false information in an application for insurance, a life settlement, or a  
13 purchase agreement may be subject to civil and criminal penalties.”

14           2. A person may not use the lack of the statement required under subd. 1. as  
15 a defense to any prosecution for a violation of this subsection or sub. (13).

16           (e) 1. Any person engaged in the business of life settlements having knowledge  
17 or a reasonable belief that a violation of this subsection or sub. (13) is being, will be,  
18 or has been committed shall provide to the commissioner the information required  
19 by, and in a manner prescribed by, the commissioner.

20           2. Any other person having knowledge or a reasonable belief that a violation  
21 of this subsection or sub. (13) is being, will be, or has been committed may provide  
22 to the commissioner the information required by, and in a manner prescribed by, the  
23 commissioner.

24           (f) 1. In the absence of actual malice, no civil liability shall be imposed on and  
25 no cause of action shall arise from a person’s furnishing information concerning

1 suspected, anticipated, or completed violations of this subsection or sub. (13) or  
2 suspected, anticipated, or completed fraudulent insurance acts, if the information is

6 b. Federal, state, or local law enforcement or regulatory officials or their  
7 employees, agents, or representatives.

8 c. A person involved in the prevention and detection of fraud or that person's

19 (g) Information, documents, and evidence provided under par. (e) or obtained  
20 by the commissioner in an investigation of suspected or actual violations of this  
21 subsection or sub. (13) shall be privileged and confidential, shall not be a public  
22 record, and shall not be subject to discovery or subpoena in a civil or criminal action.  
23 The commissioner may release information, documents, and evidence provided  
24 under par. (e) or obtained in an investigation of suspected or actual violations of this  
25 subsection or sub. (13) in administrative or judicial proceedings to enforce laws

1 administered by the commissioner, to federal, state, or local law enforcement or  
2 regulatory agencies, to an organization established for the purpose of detecting and

10 1. Preempt the authority or relieve the duty of law enforcement or regulatory  
11 agencies other than the commissioner to investigate, examine, and prosecute

14 concerning life settlement fraud to a law enforcement or regulatory agency other  
15 than the commissioner.

16 3. Limit the powers granted elsewhere by the laws of this state to the  
17 commissioner to investigate and examine possible violations of law and to take  
18 appropriate action.

19 (i) 1. Providers and brokers shall have in place antifraud initiatives reasonably  
20 calculated to detect, prosecute, and prevent violations of this subsection and sub.  
21 (13). The commissioner may modify the antifraud initiatives from time to time as  
22 necessary to ensure an effective antifraud program and to accomplish the purpose  
23 of this paragraph.

24 2. Antifraud initiatives shall include having fraud investigators, who may be  
25 employees of the provider or broker or who may be independent contractors, and an

11 d. A description or chart outlining the organizational arrangement of the

15 3. Antifraud plans submitted to the commissioner are privileged and  
16 confidential, are not a public record, and are not subject to discovery or subpoena in  
17 a civil or criminal action.

18 **(16) CONFLICTS OF LAW.** If there is more than one owner on a single policy and  
19 the owners are residents of different states, a life settlement shall be governed by the  
20 law of the state in which the owner having the largest percentage ownership resides  
21 or, if the owners hold equal ownership, the state of residence of one owner agreed  
22 upon in writing by all owners.

23 **(17) FRATERNAL BENEFIT SOCIETIES.** Nothing in this section shall prohibit a  
24 fraternal benefit society under ch. 614 from enforcing the terms of its bylaws or rules  
25 regarding permitted beneficiaries and owners.

1           **(18) CIVIL ACTION.** Any person damaged by a violation of this section may bring  
2 a civil action against the person committing the violation in a court of competent  
3 jurisdiction.

4           **(19) PENALTIES.** Any person who violates this section is subject to the penalties  
5 provided under s. 601.64, suspension or revocation of a license or certificate of  
6 authority, and an order under s. 601.41.

7           **(20) POWERS OF COMMISSIONER.** The commissioner may do any of the following:

8           (a) Adopt rules implementing and administering this section.

9           (b) Establish standards for evaluating the reasonableness of payments under  
10 life settlement contracts for persons who are terminally or chronically ill, including  
11 regulation of discount rates used to determine the amount paid in exchange for  
12 assignment, transfer, sale, devise, or bequest of a benefit under a policy insuring the  
13 life of a person who is terminally or chronically ill.

14           (c) Establish appropriate licensing requirements and standards for continued  
15 licensure for providers and brokers.

16           (d) Require a bond or other mechanism for financial accountability for  
17 providers and brokers.

18           (e) Adopt rules governing the relationship and responsibilities of insurers,  
19 providers, and brokers during settlement of a policy.

20           **SECTION 17. Initial applicability.**

21           (1) This act first applies to life settlement contracts and purchase agreements  
22 entered into on the effective date of this subsection

23           **SECTION 18. Effective date.**
