Description Discharge from employment of a passenger-for-hire vehicle operator solely on the basis of having been involved in a single motor vehicle accident					

Assumptions Used in Arriving at Fiscal Estimate

This bill prohibits employers who operate businesses that offer vehicles for the conveyance of passengers for hire from discharging from employment an individual who is hired to operate such a vehicle. The bill further protects individuals from retaliation for filing a complaint concerning this bill or participating in an investigation of a complaint filed under this bill. The bill requires the department to report violations to state and local government units who then are barred from awarding the offending party a contract for services for the next three years.

The department estimates this bill protect approximately 6,400 drivers employed in Wisconsin and that annually the department will receive fewer than ten complaints alleging a violation of the protections in this bill. The department believes it can absorb this increased workload in its current budget.

Receiving less than ten complaints per year the department estimates it will find no more than three violations per year it will need to report to state departments and local government units. The department estimates contacting approximately 2,380 local government units and state departments to notify them of each violation will cost the department \$1,690 per mailing. With three mailings per year the total cost will be about \$5,070 which the department believes it can absorb.

The department incur one-time costs of about \$1,500 to print informational materials concerning this legislation.
