Description Duplicate hunting licenses issued to persons who are 10 or 11 years old		

Assumptions Used in Arriving at Fiscal Estimate

Bill Summary: This bill reduces the price for duplicate licenses for 10 and 11 year olds who are hunting under the new mentorship program. This bill also corrects a drafting error that occurred in 2009 Wisconsin Act 39. This drafting error inadvertently left out the word "or" at the end of s. 29.304(3)(a)1. As a result of this missing word "or", youth age 14 and 15 could hunt accompanied by an adult, but the missing "or" did not extend unaccompanied hunting to those who have completed hunter education courses.

Fiscal Effect: This bill will reduce the fees for duplicate licenses for 10 and 11 year olds from \$15.00 for licenses with deer tags to \$5.00 (\$4.25 plus \$.75 issuance fee). The original licenses cost \$7.00. In addition the fee for a duplicate license for a small game license is currently \$10.00 and would now be \$5.00 (\$4.25 plus \$.75 issuance fee). In 2009, there were only 60 requests for duplicating these licenses for 10 to 11 year olds. The fiscal impacts will be minimal.

There will be no programming costs or staff costs to implement the new fees.
