Description

Assumptions Used in Arriving at Fiscal Estimate

This bill requires the Department of Children and Families (DCF), a county department, contracting agency, or school board to perform a criminal history search of child care providers and other relevant persons more frequently than under current law. This bill would increase the frequency of checks from once every four years to every 90 days.

Criminal history searches are completed in Department of Justice (DOJ) databases and caregiver background searches through the Department of Health Services (DHS). The caregiver background checks involve searches of licensing databases and the DHS client abuse registry.

Checks must be performed by DCF for child care providers and nonclient residents, and by child care providers for all of their employees. The cost of these background checks is borne by the entity who requests the check. The cost of the background check varies depending on the type of provider and whether the check is requested via the internet, by mail, or fax. If a background check is requested by a non-profit agency or a government agency via internet, the cost for the combined DOJ criminal history check and the DHS caregiver background check is \$10. Any other child care provider would pay \$16.00. If the request is submitted by fax or mail, the cost is \$15 for non-profit or government agencies, and \$21 for other day care providers. In each circumstance, DHS receives \$2.75 of the fee. The funds are deposited in s. 20.435(6)(jm) and used to support the cost of the automated system that processes search requests. The fee is waived for state agencies.

The Department of Children and Families (DCF) states there are currently 8,500 licensed and certified providers in the state. Of these providers, 2,600 are county-certified providers who would be required to pay a fee. Under this bill, provider background searches will increase from once every 4 years to 4 searches per year. Currently, approximately 1,950 background checks are conducted annually for providers. Assuming that 2,600 providers and 5,200 non-client residents who reside in a provider's home will require background searches, the number of searches conducted by counties would be expected to increase by 29,250 per year.

In addition, this bill requires day care providers' to increase the frequency of background searches on caregiving employees from once every four years to every 90 days. DCF estimates the current number of employee searches is 5,313 per year. This bill's requirements would increase the number of employee searches to approximately 85,010 per year, a net increase of approximately 79,700 searches.

If this bill is passed, DHS would expect to process an additional 108,950 background searches per year for which DHS would receive estimated additional fee revenues of \$299,600 annually.

Caregiver background checks are processed by DHS through an automated system. For persons who request the criminal history check by mail, increased costs to DHS for postage and other mailing fees are estimated to be \$10,500. The \$299,600 in increased revenue would be used to cover those costs and for the ongoing operation of the background check system.

Last, the bill requires any employee of DCF, DHS, a county, or a tribal governing body who reasonably suspects fraudulent activity on the part of a participant in the Wisconsin Works program to immediately

report the facts and circumstances contributing to that suspicion to the district attorney. The bill provides for fines and imprisonment for individuals who fail to report. It is not expected that these provisions will result in increased expenses to DHS.
