

Dear Mr. Dieter,

I understand that you are in a situation where as a building owner, you have incurred significant expenses to provide the required facilities for a Charter School in your building.

However, your tenant, a Charter School, has defaulted on his lease and has not paid for the required expenses while continuing to receive States funds.

As President of the Wisconsin Chapter of the Association of Licensed Architects, I am aware of other similar situations where architects, designers, contractors, sub-contractors and vendors are not being paid for their services provided to private Charter Schools, especially in the Milwaukee Parental Choice Program, but yet being subsidized with public monies.

I personally believe that there should be some governmental rules that would regulate these Charter Schools and withhold funding until all outstanding debts, expenses and other requirements of the programs associated with the formulation of such schools are satisfied.
