



**ASSEMBLY AMENDMENT 13,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2011 ASSEMBLY BILL 40**

June 14, 2011 – Offered by Representatives GRIGSBY, ROYS, PASCH, E. COGGS, BERNARD SCHABER, HULSEY, KESSLER, HEBL, BEWLEY, SEIDEL, TURNER, TOLES, FIELDS and YOUNG.

- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 216, line 19: increase the dollar amount for fiscal year 2012–13 by
3 \$4,250,000 to increase funding for the purpose for which the appropriation is made.
- 4 **2.** Page 218, line 4: increase the dollar amount for fiscal year 2011–12 by
5 \$3,919,000 and increase the dollar amount for fiscal year 2012–13 by \$6,003,900 to
6 increase funding for the Wisconsin Works program.
- 7 **3.** Page 549, line 14: delete the material beginning with that line and ending
8 with page 559, line 7.
- 9 **4.** Page 563, line 13: delete lines 13 to 15 and substitute:
- 10 “(b) Any action taken under par. (a) must reduce costs through administrative
11 efficiencies and not through reduced benefits.

1 (c) Before taking an action under par. (a), the department shall submit its plan
2 for implementing the proposed action to the cochairpersons of the joint committee on
3 finance for review by the committee. If the cochairpersons of the committee do not
4 notify the department that the committee has scheduled a meeting for the purpose
5 of reviewing the plan within 14 working days after the date of the department's
6 submittal, the department may implement the proposed action in accordance with
7 its plan. If, within 14 working days after the date of the department's submittal, the
8 cochairpersons of the committee notify the department that the committee has
9 scheduled a meeting for the purpose of reviewing the plan, the department may not
10 implement the proposed action unless the committee approves the plan. If the
11 committee modifies and approves the plan, the department may implement the
12 proposed action only as modified by the committee.”.

13 **5.** Page 563, line 16: delete the material beginning with that line and ending

15 **6.** Page 564, line 23: delete “\$74,650,100” and substitute “\$78,972,900”.

16 **7.** Page 564, line 24: delete “\$72,131,500” and substitute “\$78,942,900”.

17 **8.** Page 566, line 2: delete “\$301,631,000” and substitute “\$301,227,200”.

18 **9.** Page 566, line 3: delete “\$298,523,500” and substitute “\$297,716,000”.

19 **10.** Page 572, line 1: delete the material beginning with “(d)” and ending with
20 “statute,” on line 2 and substitute:

21 “(d) 1. Before implementing a policy proposed under par. (c) or before
22 promulgating a rule that makes changes to the Medical Assistance program, the
23 department shall submit to the joint committee on finance the proposed policy or
24 rule. If the cochairpersons of the committee do not notify the department within 14

1 working days after the date of the department's submittal that the committee has
2 scheduled a meeting for the purpose of reviewing the proposed policy or rule, the
3 proposed policy may be implemented, or the rule may be promulgated, as proposed
4 by the department. If, within 14 working days after the date of the department's
5 submittal, the cochairpersons of the committee notify the department that the
6 committee has scheduled a meeting for the purpose of reviewing the proposed policy
7 or rule, the proposed policy may be implemented, or the proposed rule may be
8 promulgated, only on approval of the committee.

9 2. Before implementing a policy proposed under par. (c),”.
