**SENATE AMENDMENT 1,
TO SENATE BILL 11**

February 17, 2011 – Offered by JOINT COMMITTEE ON FINANCE.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: delete “an appropriation” and substitute “appropriations”.

3 **2.** Page 9, line 21: after that line insert:

4 “**SECTION 5m.** 13.488 (1) (m) of the statutes is amended to read:

5 13.488 (1) (m) The duty to ~~compute~~ determine and make payments to the
6 United States required under ~~26 USC 148 (f)~~ so that public debt, revenue obligations
7 and operating notes issued pursuant to ch. 18 will not be treated as arbitrage bonds
8 for the purpose of exclusion from gross income under 26 USC 103 (b) (2) so as to avoid
9 an adverse effect on any exclusion of interest from gross income for federal income
10 tax purposes on public debt, revenue obligations, and operating notes issued
11 pursuant to ch. 18, master lease obligations issued pursuant to s. 16.76, and
12 appropriation obligations issued pursuant to s. 16.527 and to make any payments to
13 advisors that assist in making the determination. If the proceeds of an obligation are

1 utilized for an activity that is financed from program revenue, the building
2 commission shall make the ~~payment~~ payments required under this paragraph from
3 that revenue, to the extent it is available.”.

9 “(2) If there is any outstanding public debt, a portion of which was used to
10 finance the acquisition, construction, or improvement of any plant that is sold, or is
11 the subject of a contract for operation, under sub. (1), the department shall determine
12 any actions that may be necessary or appropriate so as not to adversely affect any
13 exclusion of interest on such public debt from gross income for federal income tax
14 purposes, including payments to advisors or the federal internal revenue service.
15 The department shall apply the net proceeds from any sale of a plant to do all of the
16 following:

17 (a) To make any payments to advisors or the federal internal revenue service
18 determined by the department to be necessary or appropriate.

19 (b) If the plant was acquired, constructed, or improved with federal financial
20 assistance, to repay the federal government, as required by federal law.

21 (c) To deposit a sufficient amount of the net proceeds from any sale of the plant
22 in the bond security and redemption fund under s. 18.09 to repay the principal and
23 pay the interest on such portion of the public debt, and any premium due upon
24 repayment of such portion of the public debt.

1 **(3)** Except as provided in s. 51.06, the department shall deposit in the budget
2 stabilization fund any net proceeds in excess of the amount required to be deposited
3 or paid under sub. (2).”.

13 the purpose of reviewing the proposed sale, the plant may be sold under sub. (1) only
14 upon approval of the committee. Together with any notification, the department
15 shall also provide all of the following:

16 (a) The estimated value of the plant as determined by the department and by
17 at least one qualified privately owned assessor.

18 (b) The full cost of retiring any remaining public debt incurred to finance the
19 acquisition, construction, or improvement of the plant.

20 (c) A cost-benefit analysis that considers the short-term and long-term costs
21 and benefits to the state from selling, leasing, or contracting for the operation of the
22 plant.

23 (d) The length and conditions of any proposed sale, lease, or service agreement
24 between this state and a proposed purchaser, lessee, or contractor.

1 (e) The estimated budgetary impact of the proposed sale, lease, or contractual
2 operation upon affected state agencies for at least the current and following fiscal
3 biennium.

4 (f) Any other information requested by the committee.”
