

ASSEMBLY AMENDMENT ,
TO 2011 ASSEMBLY BILL 233

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: delete "public works project that is" and substitute "state
3 public works project, the cost of which is less than \$500,000 and".

4 **2.** Page 1, line 3: delete "funded" and substitute "funded from donations raised
5 by friends groups".

6 **3.** Page 2, line 1: delete lines 1 to 11 and substitute:

7 "SECTION 1m. 103.49 (3g) (i) of the statutes is created to read:

8 103.49 (3g) (i) A project of public works for which the estimated cost of project
9 completion is less than \$500,000 and in which not less than 85 percent of that cost
10 is privately funded from donations raised by friends groups, as defined in s. 27.016

11 (1) (b), ^{in which} the completed facility is dedicated to the state without compensation for

in which

1 ownership by the state, and the completed facility is used for conservation,
2 recreational, or educational purposes.”.
