Eric,

Rep. Williams would like an amendment drafted for AB 303. The amendment is to amend the appropriation changes in the bill and instead reduce the amount of the recording fee collected and remitted to the state under s. 59.72 (5). Stats. Please draft an amendment that makes the following changes to AB 303:

1. Page 2, lines 6-7: delete all of the inserted language starting with, ", other than the first \$2,000,000"

2. Page 5, lines 15-20: delete all of Section 15, entitled "Fiscal Changes."

Amend s. 59.72 (5) (b) (intro), Stats., so that a county may retain \$9 of the \$10 fee.

Amend s. 59.72 (5) (b) 3. Stats. to reflect that the county may retain \$9, not \$8. In subd. 3 the county has to spend \$6 for certain activities and \$2 for other activities, so please allow the additional \$1 to be spent for either of these two activity areas.

Make the changes to s. 59.72 (5), Stats., effective July 1, 2015. (This is because DOA has lapsing requirements

on them until 2015.


