1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 3: after that line insert:

3 "SECTION 3e. 20.505 (1) (co) of the statutes is created to read:

4 20.505 (1) (co) *Comprehensive planning; local government reimbursements.* A
5 sum sufficient to reimburse local governmental units for comprehensive planning
6 expenses under s. 66.1001 (9).".

7 2. Page 5, line 14: after that line insert:

8 "SECTION 14m. 66.1001 (9) of the statutes is created to read:

9 66.1001 (9) REIMBURSEMENT OF PLANNING EXPENSES. The department of
10 administration shall reimburse a local governmental unit that has in effect a
11 comprehensive plan for any costs incurred in developing the comprehensive plan.".
