# ASSEMBLY AMENDMENT, TO 2011 ASSEMBLY BILL 303





1 At the locations indicated, amend the bill as follows:

1. Page 2, line 3: after that line insert:

**SECTION 3e.** 20.505 (1) (co) of the statutes is created to read:

20.505 **(1)** (co) *Comprehensive planning; local government reimbursements.* A sum sufficient to reimburse local governmental units for comprehensive planning expenses under s. 66.1001 (9)."

**2.** Page 5, line 14: after that line insert:

**"Section 14m.** 66.1001 (9) of the statutes is created to read:

66.1001 **(9)** REIMBURSEMENT OF PLANNING EXPENSES. The department of administration shall reimburse a local governmental unit that has in effect a comprehensive plan for any costs incurred in developing the comprehensive plan.".
