2 1. Page 14, line 4: delete lines 4 to 8.

3 2. Page 15, line 1: delete lines 1 to 9.

4 3. Page 21, line 22: after "thereof" insert "that is funded from the general  
5 fund".

6 4. Page 21, line 23: after "statutes" insert "and that is assigned duties relating  
7 to economic development programs of the department of commerce".

8 5. Page 22, line 2: delete "of the statutes" and substitute "(1) or (4) of the  
9 statutes that are used to fund economic development programs of the department of  
10 commerce".
