

“(c)<sup>✓</sup> Completion of the activity affecting the wetland area<sup>(as)</sup> described in par.  
(a)<sup>✓</sup> will not subsequently affect its being subject to regulation as a wetland under s.  
29.601 (3)<sup>✓</sup> or chs. 30, 31, 281, 283, 289 to 292 or 299<sup>✓</sup> or under any rule promulgated,  
order issued<sup>(or)</sup> ordinance adopted under any of those sections or chapters.”<sup>✓</sup>
