1 **Relating to:** modifying the session schedule for the 2011-12 biennial session period
2 and extending the floorperiod beginning on February 22, 2011.

3 ***Resolved by the assembly, the senate concurring, That:***

4 **SECTION 1. 2011-2012 Session schedule modified.** The session schedule of
5 the legislature set forth by 2011 Senate Joint Resolution 1 (Enrolled Joint Resolution
6 1) is modified as follows:

7 (1) **SECOND FEBRUARY FLOORPERIOD EXTENDED.** The floorperiod beginning on
8 February 22, 2011, and ending on February 24, 2011, set by 2011 Senate Joint
9 Resolution 1 (Enrolled Joint Resolution 1) is extended to Monday, March 7, 2011.
