2011 ASSEMBLY BILL 252

September 15, 2011 – Introduced by Representatives Petrowski, Ripp, Ballweg, Endsley, Brooks, Krug, Jorgensen, Mursau, Petryk, Rivard, Spanbauer and Steineke, cosponsored by Schators Lazich, Lasee, Grothman, Hansen and Schultz. Referred to Committee on Transportation.

AN ACT to amend 348.17 (5) of the statutes; relating to: seasonal weight

limitations for certain vehicles transporting agricultural crops.

Analysis by the Legislative Reference Bureau

Under current law, with limited exceptions, no person may operate upon a highway any vehicle or combination of vehicles that exceeds certain statutory weight limits unless the person obtains a permit issued by the Department of Transportation or a local authority. Under one exception, certain vehicles or vehicle combinations transporting agricultural crops may, without a permit, exceed weight limits by not more than 15 percent from September 1 to November 30 of each year.

This bill extends the annual end date for this exception from November 30 to December 31.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 348.17 (5) of the statutes is amended to read:

348.17 **(5)** From September 1 to November 30 <u>December 31</u> of each year, no permit shall be required for the transportation of corn, soybeans, potatoes,
