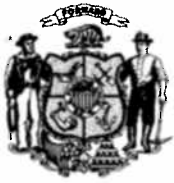

TO ASSEMBLY SUBSTITUTE AMENDMENT (LRBs0220/1),
TO 2011 SENATE BILL 18

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 4, line 17: delete that line and substitute "the individual reaches the
3 age of 26."

4 **2.** Page 8, line 11: after that line insert:

5 "SECTION 13m. 66.0137 (5) (c) 3. b. of the statutes is amended to read:

6 66.0137 (5) (c) 3. b. The individual is a full-time or part-time student in an
7 accredited college or university, except that this subd. 3. b. does not apply to such an
8 individual after the close of the calendar year in which the individual reaches the age
9 of 27 26."
