Amendments to the Sub for SB 22

Hi Peter,

We would like two amendments drafted to the sub for SB 22. The first is replacing the text beginning on page 4, line 6, omitting "the state superintendent of public instruction and" and then after the colon, inserting the following language to replace line 8 on page 4 and lines 1-3 on the top of page 5:

- (b) The charter board is a statewide charter school sponsor composed of the following seven (7) members appointed to four (4) year terms:
- (1) Two (2) members, one of whom must have experience either on a charter school board or as an authorizer of four or more schools, appointed by the governor.
- (2) The state superintendent or his/her designee.
- (3) Four (4) members, who may not be legislators, appointed as follows:
- (A) One (1) member appointed by the majority leader of the senate.
- (B) One (1) member appointed by the minority leader of the senate.
- (C) One (1) member appointed by the speaker of the house of representatives.
- (D) One (1) member appointed by the minority leader of the house of representatives.
- (c) The governor shall appoint the chairperson of the charter board.

The second one is an amendment that would only allow the state board to authorize charter schools in districts with 2000 or more students.
