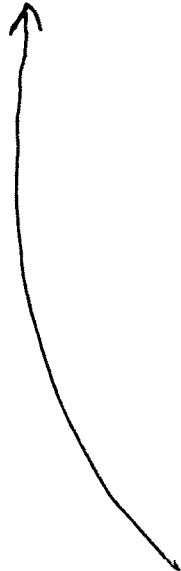
We've got a document published as SA9-ASA1-SB22, but there's no such thing as ASA1-SB22:
