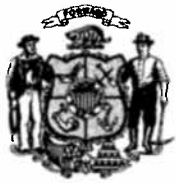
Hi Cathlene,

SENATE AMENDMENT ,
TO 2011 SENATE BILL 88

1 At the locations indicated, amend the bill as follows:

2 1. Page 7, line 20: after that line insert:

3 “(7) SURRENDER OF VICIOUS DOG. A court that sentences a person who is
4 convicted of violating sub. (3) may order that the vicious dog that is involved in the
5 violation be delivered to the local humane officer or society, to the county or
6 municipal pound, or to a law enforcement officer if the court considers the order to
7 be reasonable and appropriate. The society, pound, or officer shall release the vicious
8 dog to a person other than the person convicted of violating sub. (3) or dispose of the
9 vicious dog in a proper and humane manner. The release or disposal shall be in
10 accordance with s. 173.23 (1m).”
