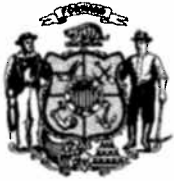

- 1 At the locations indicated, amend the bill as follows:

- 3 the ice cream sundae as the Wisconsin state dessert”.
- 4 **2.** Page 1, line 4: delete “dessert” and substitute “confection”.
- 5 **3.** Page 1, line 5: before that line insert:
- 6 “SECTION 1m. 1.10 (3) (u) of the statutes is created to read:
- 7 1.10 (3) (u) The ice cream sundae is the state dessert.”.
- 8 **4.** Page 2, line 2: after “tartan,” insert “confection.”.
