Hi Robin,

As I left on your voicemail, Senator Lassa may like these simple amendments to SB 126.

- Initial applicability changes per conversation with David Lovell with separate initial applicability provisions for the two parts of the bill:
 - The stumpage fee provision would first apply to stumpage fees payable under current law on the effective date of the act. Thus, any stumpage fees that would otherwise be affected by the bill are **not** affected; only future payments are affected.
 - The acreage share provision would first apply to acreage share payments payable on the effective date of the act. Thus, an affected land owner who is paying a higher acreage share under a renewed MFL order would see those payments drop back to the level under the prior order for the remainder of the first 10 years of the new order, but payments made to local governments between the effective date of the new agreement and the effective date of the act would **not** be affected.
- Change “quarter quarter quarter sections” to “quarter quarter sections”
- Allow the department to extend the due date for the payment of yield taxes for 10 years **or before the land is sold.**

2 **1.** Page 3, line 9: after that line insert:

3 "1m. "Original order" means a managed forest land order that is in effect on the
4 date on which a catastrophic event occurs."

5 **2.** Page 3, line 18: delete lines 18 to 23 and substitute:

6 "(c) 1. For 10 years following the expiration of an original order, an owner of
7 managed forest land described under par. (b) may pay, for those tracts that qualify
8 for an extension of the due date of yield taxes under s. 77.87 (3m), the annual per acre
9 amount established under the original order instead of the annual per acre amount
10 established under any renewal of the original order provided that the managed forest
11 land continues to be subject to a managed forest land order.

12 2. If both the catastrophic event and the renewal of the original order occur
13 before the effective date of this subdivision [LRB inserts date], then beginning on

1 the effective date of this subdivision [LRB inserts date], and ending 10 years
 2 following the expiration of the original order, the owner may pay the annual per acre
 3 amount established under the original order instead of the annual per acre amount
 4 established under the renewal of the original order.

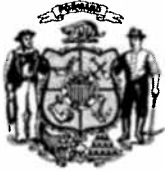
