

At the locations indicated, amend the bill as follows:

1. Page ¹⁵14, line ¹³18: after that line insert:

"SECTION ^{28g}24g, 77.86 (6) of the statutes is renumbered 77.86 (6) (intro.) and amended to read: ^{28g}

77.86 (6) EXCEPTION. (intro.) This section does not apply to an owner who cuts wood on managed forest land for any of the following purposes:

(a) For use as fuel in the owner's dwelling.

SECTION ^{28k}24k, 77.86 (6) (b) of the statutes is created to read:

77.86 (6) (b) For giving, without compensation, not more than 20 cords of wood to another person for use as fuel in that person's dwelling."
