

1. Page 14, line 18: after that line insert:

3 "Section 24g 77.86 (6) of the statutes is renumbered 77.86 (6) (intro.) and 4 amended to read:

77.86 **(6)** Exception. (intro.) This section does not apply to an owner who cuts wood on managed forest land for <u>any of the following purposes:</u>

(a) For use as fuel in the owner's dwelling.

SECTION 24k, 77.86 (6) (b) of the statutes is created to read:

77.86 **(6)** (b) For giving, without compensation, not more than 20 cords of wood to another person for use as fuel in that person's dwelling.".
