AN ACT ...; relating to: birth certificates for Milwaukee County residents.

Analysis by the Legislative Reference Bureau

Under current law, beginning with the 2012 spring primary election, an individual must present proof of identification that includes a photograph of the individual to vote in an election. Under current law, a driver's license or a state identification card issued by the Department of Transportation are permissible forms of identification for voting.

Under this bill, a resident of Milwaukee County may obtain a free birth certificate in order to obtain a driver's license or identification card for one year following the effective date of the bill if the resident needs the driver's license or identification card for the purpose of voting.

For further information see the state and local fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:
