Tim,  
I hate to say it but I just noticed what I consider to be a drafting error in AB-267. It is basically a technical or "structural" error resulting from the fact that section 348.08 (1) has a very unusual intro., ending in "except that:" instead of "except:".

In my view, because of the way the intro. is written, the draft should have some additional words added. On p. 3, line 2, after "3rd vehicle," I think the words "may, without a permit, be operated on a highway" should be added. This would make the provision consistent with the intro. and similar to other paragraphs of s. 348.08 (1).

Sorry I did not notice this earlier. Do you want me to prepare an amendment?
