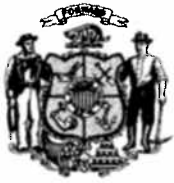

SECTION 1x?. 12.60 (1) (b) of the statutes is amended to read:

1 12.60 (1) (b) Whoever violates s. 12.03, 12.05, 12.07, 12.08 or 12.13 (2) (b) 8.,
 2 (3) (b), (c), (d), (g), (i), (n) to (x), (ze), [✓](zf), (zm) or (zn) may be fined not more than
 3 \$1,000, or imprisoned not more than 6 months or both.”.
