SENATE AMENDMENT,  
TO 2011 SENATE BILL 292

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 7: after "\$100" insert "and, in the case of a personal campaign  
3 committee or authorized support committee under s. 11.05 (3) (p) that is supporting  
4 a candidate for an office having a term of not more than 2 years, the principal place  
5 of employment, if any, of each individual contributor whose cumulative contributions  
6 for the calendar year are in excess of \$250, or in the case of any other registrant, the  
7 principal place of employment, if any, of each individual contributor whose  
8 cumulative contributions for the calendar year are in excess of \$500".
