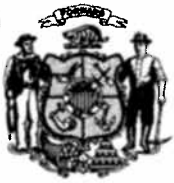

7 officer at a rate that varies in relation to the number of signatures of electors

11 (3) (b), (c), (d), (g), (i), (n) to (x), (ze), (zf), (zm) or (zn) may be fined not more than
12 \$1,000, or imprisoned not more than 6 months or both."
