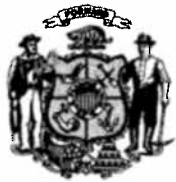

2 ✓ 1. Page 1, line 2: after "once" insert "^{misrepresenting} ~~and misrepresentation~~ of the content of
3 a recall petition".

4 ✓ 2. Page 1, line 3: delete "a penalty" and substitute "penalties".

5 ✓ 3. Page 1, line ⁶: after that line insert:

6 "SECTION 1m³. 12.13 (3) (zq) of the statutes is created to read:

7 12.13 (3) (zq) Misrepresent the true content of a recall petition to an elector in
8 the course of soliciting the elector to sign the petition."

9 ✓ 4. Page 2, line 3: delete "or (zp)" and substitute "(zp), or (zq)". ✓
