**SENATE AMENDMENT 1,
TO 2011 SENATE BILL 477**

February 22, 2012 – Offered by Senator LASSA.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 5, line 9: delete the material beginning with “does not” and ending with
3 “corporation” on line 10 and substitute “, as a condition of employment, is required
4 to work less than 37.5 hours per week unless the position is provided by an employer
5 who does any of the following:

6 a. Pays at least 50 percent of the health insurance benefit premium cost for the
7 individual.

8 b. Provides health insurance benefits that are utilized by at least 50 percent
9 of the employer’s employees.

10 c. Provides other employee health insurance benefits to the individual that are
11 acceptable to the corporation.”.

12 **2.** Page 6, line 7: delete lines 7 and 8 and substitute:

1 **“SECTION 12m.** 238.30 (2m) (b) of the statutes, as affected by 2011 Wisconsin
2 Act 32, is renumbered 238.30 (2m) (b) (intro.) and amended to read:”.

3 **3.** Page 6, line 9: after “238.30 **(2m)** (b)” insert “(intro.)”.

4 **4.** Page 6, line 13: delete the material beginning with “~~, as a~~” and ending with
5 “week” on line 14 and substitute “, as a condition of employment, is required to work
6 less than 37.5 hours per week unless the job is provided by an employer who does any
7 of the following:”.

8 **5.** Page 6, line 14: delete the material beginning with “does not” and ending
9 with “corporation.” on line 15.

10 **6.** Page 6, line 15: after that line insert:

11 **“SECTION 12n.** 238.30 (2m) (b) 1., 2. and 3. of the statutes are created to read:

12 238.30 **(2m)** (b) 1. Pays at least 50 percent of the health insurance benefit
13 premium cost for the individual.

14 2. Provides health insurance benefits that are utilized by at least 50 percent
15 of the employer’s employees.

16 3. Provides other employee health insurance benefits to the individual that are
17 acceptable to the corporation.”.

18 **7.** Page 6, line 16: delete lines 16 and 17 and substitute:

19 **“SECTION 13m.** 238.399 (1) (am) 2. of the statutes, as affected by 2011 Wisconsin
20 Act 32, is renumbered 238.399 (1) (am) 2. (intro.) and amended to read:”.

21 **8.** Page 6, line 18: after “238.399 **(1)** (am) 2.” insert “(intro.)”.

22 **9.** Page 6, line 22: delete the material beginning with “~~, as a~~” and ending with
23 “week” on line 23 and substitute “, as a condition of employment, is required to work

1 less than 37.5 hours per week unless the job is provided by an employer who does any
2 of the following:”.

3 **10.** Page 6, line 23: delete the material beginning with “does not” and ending
4 with “corporation.” on line 24.

5 **11.** Page 6, line 24: after that line insert:

6 “**SECTION 13n.** 238.399 (1) (am) 2. a., b. and c. of the statutes are created to read:
7 238.399 (1) (am) 2. a. Pays at least 50 percent of the health insurance benefit
8 premium cost for the individual.

9 b. Provides health insurance benefits that are utilized by at least 50 percent
10 of the employer’s employees.

11 c. Provides other employee health insurance benefits to the individual that are
12 acceptable to the corporation.”.
