2011 SENATE BILL 511

February 23, 2012 – Introduced by Senators Hansen, King, Holperin, Taylor, Lassa, S. Coggs, T. Cullen and Miller, cosponsored by Representatives Mason, Grigsby, Pasch, Milroy, Richards, Jorgensen, Roys, Pocan, Steinbrink, Berceau, E. Coggs, Molepske Jr, Toles, Sinicki, Bewley, C. Taylor, Fields, Hulsey, Bernard Schaber, Pope-Roberts, Turner, Young, Vruwink and Kessler. Referred to Joint Committee on Finance.

Analysis by the Legislative Reference Bureau

Of the moneys received by the state as a result of the national mortgage foreclosure settlement, \$25,600,000 will be deposited in the general fund as general purpose revenue (GPR). This bill allocates that GPR as follows:

1. The Department of Children and Families must provide \$10,000,000 in additional aid under its emergency assistance to needy persons program to eligible persons who are homeless or facing impending homelessness due to natural disaster or foreclosure.

2. The Department of Financial Institutions must provide \$10,000,000 in grants to assist nonprofit organizations and governmental bodies for the purpose of foreclosure mediation and foreclosure prevention.

3. The Department of Veterans Affairs must provide \$3,000,000 in housing vouchers for chronically homeless veterans and in grants to veterans for preventing foreclosures on veterans' primary residences.

4. The Department of Agriculture, Trade and Consumer Protection (DATCP) must provide a grant of \$1,600,000 to the Tenant Resource Center (TRC) in Madison to enable the TRC to expand its operations statewide, establish physical offices in the five counties with the highest rates of foreclosure, and provide services related to foreclosure prevention and tenant mediation. DATCP must first approve a plan submitted by the TRC for the use of the funds, and the TRC must submit to DATCP, within six months of using the funds, a report detailing how the funds were used.

5. The director of state courts must provide a grant of \$1,000,000 to the Milwaukee Foreclosure Mediation Program (MFMP) for its general operations. The MFMP must enter into an agreement with the director of state courts that specifies the conditions for the use of the funds, and the MFMP must submit to the director of state courts, within six months of using the funds, a report detailing how the funds were used.

conditions for the use of the grant proceeds, including reporting and auditing
 requirements.

3 (d) The Tenant Resource Center agrees in writing to submit to the department
4 of agriculture, trade and consumer protection, within 6 months after spending the
5 full amount of the grant proceeds, a report detailing how the proceeds were used.

SECTION 9117. Nonstatutory provisions; Financial Institutions.

- (1) GRANTS FROM NATIONAL MORTGAGE SETTLEMENT FUNDS.
- (a) In this subsection:

9 1. "Department" means the department of financial institutions.

10 2. "Governmental body" has the meaning given in section 19.82 (1) of the11 statutes.

12 3. "Nonprofit organization" has the meaning given in section 108.02 (19) of the13 statutes.

(b) From the appropriation under section 20.144 (1) (b) of the statutes, as
created by this act, in the 2011–13 fiscal biennium, the department shall award
grants to assist nonprofit organizations and governmental bodies for the purpose of
foreclosure mediation and foreclosure prevention. To the extent possible, these
grants shall be funded from this state's share of proceeds from the national mortgage
settlement on or about February 9, 2012, that are deposited into the general fund.

(c) The department shall establish a form and procedure for grant applications,
standards for grant eligibility, and procedures and criteria for evaluating
applications and awarding grants under this subsection.

SECTION 9145. Nonstatutory provisions; Supreme Court.

(1) FORECLOSURE MEDIATION PROGRAM GRANT. From the appropriation under
 section 20.680 (2) (dy) of the statutes, as created by this act, the director of state

1	courts shall make a grant in the amount of \$1,000,000 to the Milwaukee Foreclosure
2	Mediation Program to be used for the general operating expenses of the program.

13	(1) EMERGENCY ASSISTANCE. In the schedule under section 20.005 (3) of the
14	statutes for the appropriation to the department of children and families under
15	section 20.437 (2) (dz) of the statutes, as affected by the acts of 2011, the dollar
16	amount is increased by \$10,000,000 for the second fiscal year of the fiscal biennium
17	in which this subsection takes effect to provide aid under section 49.138 of the
18	statutes to eligible persons who are homeless or facing impending homelessness due
19	to foreclosure or natural disaster.
20	SECTION 9253. Fiscal changes; Veterans Affairs.

(1) HOUSING AND FORECLOSURE ASSISTANCE. In the schedule under section 20.005
(3) of the statutes for the appropriation to the department of veterans affairs under
section 20.485 (2) (b) of the statutes, as affected by the acts of 2011, the dollar amount
is increased by \$3,000,000 for the first fiscal year of the fiscal biennium in which this

3 SECTION 9400. Effective dates; general. Except as otherwise provided in
4 SECTIONS 9403 to 9445 of this act, this act takes effect on the day after publication.

5 SECTION 9403. Effective dates; Agriculture, Trade and Consumer 6 Protection.

7 (1) TENANT RESOURCE CENTER GRANT. The repeal of section 20.115 (1) (dy) of the
8 statutes takes effect on July 1, 2013.

9 SECTION 9417. Effective dates; Financial Institutions.

- 10 (1) GRANTS BY THE DEPARTMENT OF FINANCIAL INSTITUTIONS. The repeal of sections
- 11 20.144 (1) (b) and 227.01 (13) (zz) of the statutes takes effect on July 1, 2013.
