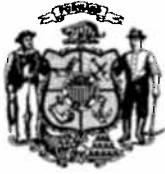

3 signing recall petitions,".

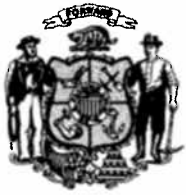
4 **2.** Page 1, line 4: before that line insert:

1 AN ACT ... relating to: intimidation or harassment of recall petition signers?

Analysis by the Legislative Reference Bureau

This bill prohibits any person from intimidating or harassing another person because that person signs or is attempting to sign a recall petition. Violators are guilty of a class I felony and may be fined not more than \$10,000 or imprisoned for not more than 6 months, or both. No similar prohibition exists currently.
