2 Whereas, David Kachel was born on October 19, 1927, in Whitewater,
3 Wisconsin, and died on February 3, 2011, at the age of 83; and

4 Whereas, David Kachel graduated from the University of
5 Wisconsin-Whitewater in 1948; and

6 Whereas, David Kachel was a tremendous, family-oriented businessman
7 involved in family-operated businesses, including Wisconsin Dairy Supply, DLK
8 Enterprises, and Commercial Bank of Whitewater and Janesville, Wisconsin; and

9 Whereas, David Kachel was dedicated and loyal to the Whitewater community
10 his entire life; and

11 Whereas, David Kachel used his success in business to give back to his
12 community; and

13 Whereas, David Kachel served on community and University of
14 Wisconsin-Whitewater boards and commissions during his life; and

1 Whereas, David Kachel donated funds to help construct many projects in the
2 City of Whitewater and for the University of Wisconsin–Whitewater; and

3 Whereas, David Kachel was influential in the construction and formation of the
4 DLK/Kachel Fieldhouse, the Kachel Family Sports Complex, the Kachel Center in
5 the Young Auditorium, the Kachel Center for Entrepreneurship on the University
6 of Wisconsin–Whitewater campus, and the Whitewater Aquatic Center in the City
7 of Whitewater; and

8 Whereas, David Kachel and his wife, Lolita, were avid fans and great
9 supporters of University of Wisconsin–Whitewater athletics; now, therefore, be it
