2 United States Army who lost his life during Operation Enduring Freedom.

3 Whereas, on February 20th, 2011, Lieutenant Hidalgo, of Waukesha,
4 Wisconsin, a member of Troop G, 3rd Squadron, 2nd Stryker Cavalry Regiment, died
5 as a result of wounds received during enemy action in Kandahar Province,
6 Afghanistan; and

7 Whereas, Lieutenant Hidalgo was a student of Kettle Moraine Middle and High
8 Schools where he wrestled and was a member of the school band; and

9 Whereas, Lieutenant Hidalgo provided faithful and honorable service to the
10 people of the State of Wisconsin and the people of the United States, as well as
11 continuing a family military tradition by being commissioned as an officer in the
12 United States Army on May 23rd, 2009, and proudly serving his tour of duty in
13 Afghanistan; and

1 Whereas, Lieutenant Hidalgo made his family, his friends, and his country
 2 extremely proud of his courage and bravery as he made the ultimate sacrifice in
 3 service to his nation in fighting for the cause of freedom; and

4 Whereas, Lieutenant Hidalgo was laid to rest in West Point, New York, on
 5 Monday, March 7th, 2011; therefore, be it

6 **Resolved by the senate, the assembly concurring, That** the legislature of
 7 the state of Wisconsin commemorates the remarkable life of First Lieutenant Daren
 8 Miguel Hidalgo and extends its deepest sympathies to his family, friends, and
 9 colleagues; and, be it further

 11 joint resolution to Daren Hidalgo's parents, Jorge and Andrea Hidalgo, and to his
