1 **Relating to:** the life and military service of United States Army Corporal Justin  
2 David Ross.

3 Whereas, Cpl. Justin D. Ross was born on September 14, 1988, in Wisconsin  
4 Rapids, Wisconsin, the son of Rev. Ronald and Deborah Ross, and died on March 26,  
5 2011, in the Helmand province of Afghanistan as a result of wounds sustained when  
6 insurgents attacked his unit; and

7 Whereas, Justin was a 2007 graduate of Bay Port High School and a 2009  
8 graduate of Universal Technical Institute; and

9 Whereas, Justin entered the United States Army Reserves in 2006, was  
10 attached to the 428th Combat Engineer Company of Wausau, and then deployed  
11 with the 863rd Engineer Battalion; and

12 Whereas, Justin was mobilized in August 2010 and deployed to Afghanistan in  
13 October 2010 as a combat engineer, whose job was to clear routes of danger and debris  
14 so other troops could move through the area; and
