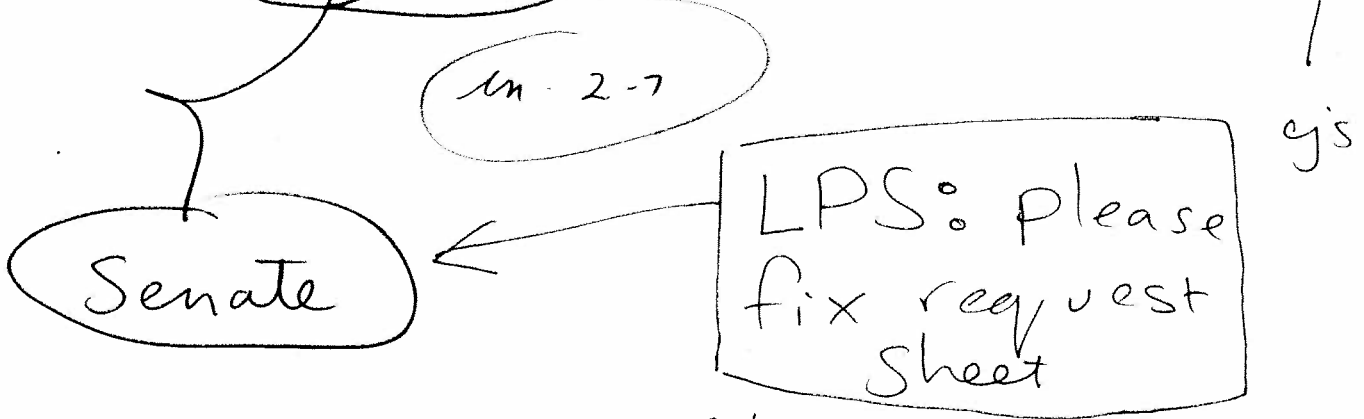

**PRELIMINARY DRAFT - NOT READY FOR INTRODUCTION**  
**2011 ASSEMBLY JOINT RESOLUTION**



- 1 **Relating to:** proclaiming March to be <sup>T</sup>Hunger <sup>N</sup>takes <sup>H</sup>no <sup>M</sup>holiday month<sup>®</sup>.
- 2       Whereas, the Second Harvest Northern Lakes Food Bank organized the third
- 3 annual Hunger Takes No Holiday, which began on February 2, 2012, and runs
- 4 through April 9, 2012; and
- 5       Whereas, during the past two Hunger Takes No Holiday events, enough
- 6 contributions have been made to provide over 100,000 meals to those in need in the
- 7 city of Superior and throughout Douglas County; and
- 8       Whereas, the Second Harvest Northern Lakes Food Bank recovers nationally
- 9 and regionally donated food, that might otherwise end up in a landfill, and provides
- 10 it to the city of Superior and Douglas County non-profit agency partners and people
- 11 in need; and
- 12       Whereas, in 2011, the Second Harvest Northern Lakes Food Bank recovered
- 13 and distributed 358,195 pounds of food for local residents, enough food for 286,556
- 14 meals; and

and

1           Whereas, the Second Harvest Northern Lakes Food Bank recovers food from  
2 national manufacturers when they overproduce goods, from Superior's Essentia  
3 Health when it has extra meals, or from Super One when it has a surplus of deli meat,  
4 produce or dairy products; and

5           Whereas, the food rescued by Second Harvest Northern Lakes Food Bank is  
6 free, with every \$1 donated providing \$10 worth of food or enough food for five meals;  
7 and

8           Whereas, the Second Harvest Northern Lake Food Bank has set an ambitious  
9 2012 fundraising goal of raising \$25,000, or the equivalent 125,000 meals, by  
10 increasing awareness of the Hunger Takes No Holiday event through local, county,  
11 and statewide proclamations in the month of March; now, therefore, be it

12           *Resolved by the assembly, the senate concurring, That* in appreciation of  
13 Second Harvest Northern Lakes Food Bank's efforts to combat hunger in Northern  
14 Wisconsin through the Hunger Takes No Holiday event, the legislature of the State  
15 of Wisconsin proclaims March to be Hunger Takes No Holiday Month; and be it  
16 further

17           *Be it further resolved, That* the senate chief clerk shall provide copies of this  
18 resolution to the executive director of the Second Harvest Northern Lakes Food  
19 Bank.
