1 **Relating to:** recognizing that it is the right, duty, and privilege of the legislature to  
2 control the expenditure of moneys appropriated by law.

3 Whereas, the federal government makes certain funds available to the state of  
4 Wisconsin; and

5 Whereas, these funds provide a significant financial resource for the state that  
6 in turn increases employment in the state; and

7 Whereas, the legislature is the appropriate branch of government to budget  
8 these funds; now, therefore, be it

9 **Resolved by the senate, the assembly concurring, That** <sup>✓</sup> it is the sense of  
10 the legislature that when the state has received or accepted any federal funding or  
11 moneys from the federal government whose expenditure would increase  
12 employment in Wisconsin, the governor may not return the money to the federal  
13 government without the approval of the legislature by law.
