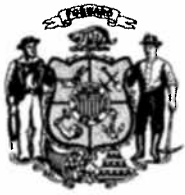

9 Whereas, the original CD release show of Bon Iver's first album took place at

12 veterinarian clinic in Fall Creek, Wisconsin; and

13 Whereas, Justin Vernon and his brother Nate bought the veterinarian clinic
