SENATE AMENDMENT ,
TO SENATE BILL 21

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 12, line 10: after that line insert:

3 “(d) The total value of all grants the board provides under this section in a fiscal
4 year may not equal more than 10 percent of the total value of all grants, loans, and
5 investments the board makes in that fiscal year.”
